#### I. COMPANY PROFILE

National Handloom Development Corporation Limited (NHDC) was incorporated on 22.02.1983 with the objective to serve as a national level agency for promotion and development of the Handloom sector. The main activity of the company is to ensure the availability of Raw Material like yarn and Dyes & Chemicals to Handloom weavers. Besides, this, NHDC is undertaking various development programmes for handloom weavers such as organization of exclusive exhibitions, Buyer-Seller meet, awareness camps and sensitization programmes so as to contribute to increase the awareness of schemes/products and marking avenues etc. NHDC is a Schedule -B CPSE with the administrative jurisdiction of the Ministry of Textiles. The company employed 116 regular employees (Executives - 77 & Non-Executives -39) as on 31.03.2023.

Its Registered and Corporate offices are at Noida (U.P.).

The authorized and paid up capital of the Company was Rs. 20 crore and Rs. 19 crore respectively as on 31.03.2023.

The share holding of the Government of India in the Company is 100%.

### II. JOB DESCRIPTION AND RESPONSIBILITIES

The Managing Director is the Chief Executive of the Company and accountable to its Board of Directors and Government/Share holders. He/She is responsible for the efficient

functioning of the company, and for achieving its corporate objectives and performance parameters.

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
- 4. In the above cases, no request for relaxation or otherwise would be entertained.
