I. INTRODUCTION

1. The Office of the Prosecutor ("Prosecution") submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified as confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

- 3. On 12 May 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani "Pre-Trial INCRIM package 066" containing 39 items, "Pre-Trial Rule 77 package 033" containing 184 items, "Pre-Trial Other package 011" containing 60 items and "Pre-Trial re-classification to INCRIM package 004" containing 6 items.
- 4. The disclosure of "Pre-Trial INCRIM package 066" consists of materials which are relevant to aspects of the chapeau elements of article 7 and 8 of the Rome Statute that are classified as incriminatory evidence. This package includes witness documents, email communications and victim complaints.
- 5. The disclosure of "Pre-Trial Rule 77 package 033" consists of witness documents and non-witness related evidence deemed material to the preparation of the Defence. This package contains documents related to witnesses P-0902, P-0903, P-0904, P-0905, P-0906, P-0907, P-0908 and P-1362. In addition, it includes press articles, audio-video material, reports, legislation, correspondence, tables, transcripts, translations and photographs.
- 6. The disclosure of "Pre-Trial Other package 011" consists of documents related to witnesses P-0311, P-1481, P-1483, P-1489, P-1495, P-2043, P-2054, P-2141, P-2142, P-

2237, P-2244, P-2288, P-2289, P-2345, P-2429, P-2436, P-2520, P-2586, P-2999, P-0409, P-1592, P-1792, P-1476 and P-1082. The Prosecution provides these items for the sake of completeness as part of its ongoing review of the evidence and under the legal classification of "Other" as they do not obviously include information material to the preparation of the Defence under rule 77 of the Rules of Procedure and Evidence.

7. The disclosure of "Pre-Trial re-classification to INCRIM package 004" consists of documents which are now re-classified as INCRIM.
