Air Baltic Corporation AS Re: Preliminary Trading Results and Revenue Figures of Year 2023 and Announcement of Investors' Call on 05 March 2024

Air Baltic Corporation AS (the Company, airBaltic) will publish its preliminary trading results and revenue figures for year 2023 on 05 March 2024. The financials will be available on the Company's website at: <u>https://investors.airbaltic.com/en/financial-information</u> on the above-indicated date.

Following a record-breaking half-year and solid Q3 results, airBaltic continues to demonstrate operational excellence and confident business indicators. According to unaudited preliminary data, the total revenue for the previous year is expected to reach EUR 668 million, marking a significant 34% year-over-year increase.

Martin Gauss, President and CEO of airBaltic: "As we approach the release of our 2023 annual results, we are excited to report that airBaltic is on track for a remarkably successful year. We eagerly await the opportunity to present these results to investors, media, and the broader public. In a wider context, 2023 has been a year of significant growth and development for airBaltic, further emphasizing our role as a key player in the aviation industry and our commitment to connecting Latvia with the world."

Summarizing the year 2023, it is evident that airBaltic has continued the Company's purposeful growth and development. Preliminary data indicates that in 2023, the airline carried approximately 4.5 million passengers, representing a 36% increase compared to 2022. In the last 12 months, the Latvian flag carrier performed over 44 thousand flights – 18% more than the year before.
