FDOT to Host Hybrid Public Information Meeting for State Road (SR) 922/NE 125 Street and SR 909/West Dixie Highway Construction Project

Thursday, September 22

MIAMI, Fla. – The Florida Department of Transportation (FDOT) is scheduled to begin an improvement project during the week of October 31, 2022, in the City of North Miami. The project limits extend along State Road (SR) 922/NE 125 Street from NE 5 Avenue to NE 7 Avenue and along SR 909/West Dixie Highway from NE 119 Street to NE 124 Street. This project includes permanent changes to the flow of traffic along sections of NE 7 Avenue, West Dixie Highway and NE 124 Street.

A public information meeting will take place to discuss this project, both in-person and virtually, **starting at 6 p.m. on Thursday, September 22, 2022.** FDOT representatives will provide an overview of the projects and will be available to answer questions.

To attend the In-Person Public Meeting:

The in-person public meeting will be held at City Hall Council Chambers 776 NE 125 Street, 2nd Floor, North Miami, FL 33161. Limited space is available. All current Centers for Disease Control and Prevention (CDC) guidelines and social distancing will be observed.

To attend the Virtual Public Meeting online:

The \$4.2-million project is expected to be completed by summer 2023. The scope of work includes: converting NE 7 Avenue to a one-way southbound street between NE 127 Street and NE 125 Street; permanently closing southbound West Dixie Highway from NE 126 Street to NE 6 Avenue; constructing a bus bay island on the west side of West Dixie Highway between NE 126 Street and NE 6 Avenue; permanently rerouting southbound West Dixie Highway traffic to westbound NE 128 Street and westbound NE 127 Street; signalizing the intersection of NE 128 Street at NE 6 Avenue; converting NE



124 Street to a two-way eastbound and westbound street between West Dixie Highway and NE 6 Avenue; providing a northbound left-turn lane at the intersection of NE 125 Street and NE 6 Avenue; providing access from eastbound NE 125 Street to southbound West Dixie Highway; improving drainage at NE 6 Avenue and West Dixie Highway; installing a new midblock crossing on West Dixie Highway just south of NE 119 Terrace; and adding a left-turn arrow to the traffic signal at West Dixie Highway and NE 119 Street. Additional work to be performed includes repaving and restriping, installing high emphasis crosswalks at all signalized intersections, upgrading pedestrian ramps, signage and pavement markings, enhancing signalization and lighting, and upgrading traffic signals.

To build this project safely, it will be necessary to close travel lanes and sidewalks at times. For NE 125 Street, closures may take place from 9 a.m. to 3:30 p.m., weekdays and weekends; 9 p.m. to 5:30 a.m., Sunday through Thursday nights; and 11 p.m. to 7 a.m., Friday and Saturday nights. For West Dixie Highway, closures may take place from 9 a.m. to 3:30 p.m. and 8 p.m. to 7 a.m. on weekdays and weekends. Work will be done in stages to minimize construction-related impacts. Please use caution when traveling through construction zones.

Please note that this schedule may change due to bad weather or other unexpected conditions.
