SenSen Wins Multi-Year Contract with Duncan Solutions to Service Toowoomba Regional Council

Leading sensor AI software and solution provider **SenSen Networks Limited (ASX:SNS, "SenSen" or "the Company")** today announced it has secured a deal with Duncan Solutions to supply automated parking enforcement solutions to Toowoomba Regional Council.

The contract has been awarded in conjunction with SenSen's distribution partner, Duncan Solutions (*duncansolutions.com.au/*), an Australian-owned company providing integrated parking solutions, software and services. This is part of Duncan's comprehensive smart parking technology infrastructure solution with the Council.

Commencing in March 2022, SenSen will deploy one mobile parking enforcement unit along with associated software and services. SenSen will earn upfront revenue for the systems, software and commissioning of the unit. SenSen will also earn annual recurring revenues and fees for the software licence, maintenance and support services under the three-year term of the contract.

As with all SenSen customer contracts, it is expected that Sensen and Duncan may further assist Toowoomba keep its roads safe and congestion free.

Toowoomba is Queensland's largest inland city, located 125km west of Brisbane in the Darling Downs region covering a population of ~170,000.
