SenSen signs agreement with Chicago Parking Meters to digitize the curb

## HIGHLIGHTS

- Chicago Parking Meters (CPM) signed a Master Services Agreement with SenSen to use its award-winning sensor AI technology to gather real time data from the curb space they manage in and around the City of Chicago.
- SenSen's contract from these vehicles mounted sensor AI systems, software and services are expected to exceed US\$1 million in FY22. The multi-year contract is expected to generate additional revenues once the current systems are fully operationalised.
