We established AFA (Singapore) in 2013 in order to capture the demand of the aviation industry, which is a global growth industry, not only domestically but also internationally. Later in 2014, we established AFN (Canada), and in 2018, AFS (Singapore), currently having three overseas subsidiaries.
