## Listed Company Information

#### Massy Holdings Ltd. (MASSY) - 12.05.2023

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from MASSY advising of the following:

- Appointment of Mr. James McLetchie as an Executive Director, effective August 15, 2023.
- Retirement of Mr. Robert Bermudez as Chairman and Independent Director, effective May 11 2023.
- Election of Mr. Robert Riley as Chairman, effective May 12, 2023.

## Agostini's Limited (AGL) - 12.05.2023

The TTSE received notice from AGL advising that they have signed a Sale and Purchase Agreement with the shareholders of Health Brands Limited, a Jamaican pharmaceutical and personal care distribution company, to acquire 100% of the issued and outstanding shares of that company.

The transaction has received regulatory approval and the due diligence process is nearing completion. It is expected that this transaction will be finalized by the end of June 2023, and will make a further announcement at that time.

## Guardian Holdings Limited (GHL) - 05.05.2023

The TTSE received notice from GHL advising that at the Annual Meeting held on May 04, 2023, Mr. Dexter Maitland was elected as a Director. Additionally, Mr. Henry Peter Ganteaume and Mr. Maxim Rochester retired from the Board and did not offer themselves for re-election. Such retirement took effect at the close of the Annual Meeting.

#### Agostini's Limited (AGL) - 05.05.2023

The TTSE received notice from AGL advising that Caribbean Distribution Partners Limited, a subsidiary of AGL, has purchased 80% of the issued and outstanding shares of Chinook Trading Canada Limited, a Canadian-based consumer product trading company that operates primarily in the Caribbean.

## Trinidad Cement Limited (TCL) - 02.05.2023

The TTSE received notice from TCL advising that further to the Notice dated March 14, 2023, TCL has sought further extensions of the regulatory deadlines for the filing and publication of TCL's Audited Financial Statement for the year ended December 31, 2022, until May 15, 2023; and Annual Report for the year ended December 31, 2022, until June 15, 2023.

### Republic Financial Holdings Limited (RFHL) - 02.05.2023

The TTSE received notice from RFHL advising that further to the Notice published on August 30, 2022, in which the proposed merger of two (2) subsidiaries of RFHL, namely Republic Bank (Cayman) Limited (RBKY) and Cayman National Bank Ltd. (CNB), subject to regulatory approvals, was announced, it is now advised that having received all requisite regulatory approvals, the merger of these two (2) entities became effective May 01, 2023.

Consequently, as RBKY's entire book of business has been transferred to CNB, RBKY is no longer a subsidiary within the Republic Group of Companies and CNB will remain the surviving entity.
