This memorandum directs the public to Docket ID No. EPA-HQ-OAR-2021-0663 to view the final rulemaking notice and related final rulemaking support materials (e.g., modeling files, technical support documents, and response to comments document) for the proposed rulemaking notices and related proposed rulemaking support materials contained in the EPA Regional office dockets listed in Table 1. Together, the EPA Office of Air and Radiation ("headquarters") docket and the EPA Regional office dockets listed in Table 1 contain all supporting documents for the EPA's proposed and final actions on certain state implementation plan submissions addressing interstate transport or "good neighbor" obligations under Clean Air Act section 110(a)(2)(D)(i)(I) for the 2015 ozone national ambient air quality standards.
