RE: Request for Authorization Action Pursuant to Clean Air Act Section 209(e) for 2022 Amendments to California's In-Use Off-Road Diesel-Fueled Fleets Regulation

## Dear Administrator Regan:

I am writing to request that the U.S. Environmental Protection Agency (EPA) grant California authorization pursuant to Clean Air Act Section 209(e) for 2022 Amendments to its In-Use Off-Road Diesel-Fueled Fleets Regulation. The California Air Resources Board (CARB) projects that the 2022 Amendments will cumulatively reduce statewide emissions of air pollutants by approximately 31,069 tons of oxides of nitrogen (NOx) and 2,711 tons of diesel particulate matter (PM) between 2024 to 2038. These emissions reductions will assist California in attaining the national and state ambient air quality standards for ozone and particulate matter, in reducing serious risks to the health and welfare of Californians, and in addressing the climate-change-induced harms posed by off-road vehicles operating in California.

I am enclosing our authorization analysis, which includes a description of California's rulemaking action, a review of the criteria governing EPA's evaluation of California's request for authorization, CARB's analysis and rationale supporting our request, and supporting documents.
