RE: Revision to the Oregon State Implementation Plan to Address the Regional Haze Second Planning Period

Dear Administrator Pirzadeh:

The Oregon Department of Environmental Quality is submitting and requests approval of the 2018 – 2028 Regional Haze State Implementation Plan to address the second planning period. This letter also provides for your approval amendments to Oregon's State Air Quality Control Plan or State Implementation Plan (SIP), adopted by reference into the Oregon Administrative Rules (OAR) at 340-200-0040 as of July 23, 2021, with an effective date of July 23, 2021.

DEQ is submitting and requests EPA approval of the enclosed SIP revision to update Regional Haze Rules at OAR 340-223-0010, 340-223-0020 and 340-223-0100 through 340-223-0130. These rules were part of a rulemaking package adopted by the Oregon Environmental Quality Commission to codify in Division 223 the screening procedure and information collection associated with Oregon's compliance with the federal Regional Haze Rule for the second planning period, 2018 - 2028. The rules also established what action is required of regulated sources to reduce haze-forming pollutants. DEQ also repealed rules that implemented the first round of Regional Haze requirements which are no longer relevant, including OAR 340-223-0030 through 340-223-0080. DEQ is requesting the repealed rules be removed from the SIP.

DEQ is also submitting and requesting EPA approval of the items referred to in Attachment 3.3, which are contained within the 2018-2028 Regional Haze Plan and attached to this cover letter. The orders DEQ is submitting for EPA's approval are contained in Appendix E of the 2018-2028 Regional Haze Plan. The permit conditions that DEQ is submitting for EPA's approval are listed in Attachment 3.3 and in Section 3.7.5 of the 2018-2028 Regional Haze Plan. To demonstrate that the permit conditions are fully enforceable, DEQ has attached copies of the official permits, which DEQ has signed, stamped, and dated, as Attachment 8.

In addition to submitting the 2018 - 2028 Regional Haze State Implementation Plan, we will submit the following required legal and supporting documents through EPA's SPeCS system:
