Per a request received on February 28, 2022, the Allegheny County Health Department is formally terminating the Title V Air Operating Permit for the GenOn facility in Cheswick, PA (#0054-OP17c, issued November 21, 2017 and amended April 1, 2022). It was confirmed on April 1, 2022 that all operations had ceased and that ownership of the property had been transferred from GenOn Holdings to the Cheswick Environmental Redevelopment Group, LLC.
