Dear Chairman Weeden:

On August 12, 2022, the U.S. Environmental Protection Agency received an application from Revolution Wind, LLC (RW) for a preconstruction permit in accordance with the Outer Continental Shelf (OCS) Air Regulations contained in 40 C.F.R. part 55. Per the *EPA Policy on Consultation and Coordination with Indian Tribes*, EPA Region 1 welcomes the opportunity to conduct government-to-government consultation prior to issuing a permit decision.

The proposed project is located in federal waters on the OCS approximately 7.5 nautical miles south of Nomans Land Island National Wildlife Refuge. Because the Revolution Wind Farm Project has the potential to emit air pollutants and is located on the OCS, it is subject to all applicable requirements contained in 40 C.F.R. part 55, including air permitting requirements.

As background, Section 328(a) of the Clean Air Act (42 U.S.C. § 7401 *et seq.*) as amended by Public Law 101-549 enacted on November 15, 1990, required the EPA to establish air pollution control requirements for OCS sources subject to the Outer Continental Shelf Lands Act (OCSLA) for all areas of the OCS, except those located in the Gulf of Mexico west of 87.5 degrees longitude<sup>1</sup>, in order to attain and maintain federal and state ambient air quality standards and comply with the provisions of part C of title I of the Act.<sup>2</sup> To comply with this statutory mandate, on September 4, 1992, the EPA promulgated "Outer Continental Shelf Air Regulations" at 40 C.F.R. part 55. *See* 57 FR 40792.

OCS sources can include wind energy development sources which are authorized under OCSLA at 43 U.S.C. 1337(p)(1)(C).<sup>3</sup> The Department of Interior delegated this authority to the Minerals

Management Service (now the Bureau of Ocean and Energy Management, or BOEM). On April 22, 2009, BOEM issued final regulations for the OCS Renewable Energy Program. These regulations, codified at 30 C.F.R. part 585, provide a framework for issuing leases, easements, and rights-of-way for OCS activities that support production and transmission of energy from sources other than oil and natural gas.

We recognize our responsibility to consult on a government-to-government basis with federally recognized tribes on efforts that may affect tribal interests. Consultation is a process of meaningful communication and coordination between the EPA and tribal officials prior to EPA taking actions or implementing decisions that may impact tribes. This letter is a formal invitation for consultation with the EPA on behalf of your Tribe to discuss the actions that we are preparing with respect to the Revolution Wind Farm Project.

To ensure that your interests are duly considered, we are prepared to consult with you, or your designees should you desire. If you would like to initiate government-to-government consultation with the EPA on this action, please contact Pujarini Maiti at (617) 918-1625, or by email at maiti.pujarini@epa.gov. If you desire government-to-government consultation with the EPA, we kindly request that you notify us by December 12, 2022. If we do not receive a response from you by this date, we will assume that you do not wish to pursue consultation on this matter and EPA Region 1 will move forward with the permitting action.
