



# CHANGE IN THE 2021 CALENDAR OF CORPORATE EVENTS

**April 8, 2021**. **Exprivia S.p.A.** - a company listed on the MTA market of Borsa Italiana [XPR.MI] – informs that the Board of Directors, which met today, has resolved to postpone the meeting of the Board of Directors for the approval of the Annual Report as at 31 December 2020 from April 14<sup>th</sup> 2021 to April 30<sup>th</sup> 2021.

The dates of the other corporate events of 2021 remain unchanged, as per the calendar published last January 29<sup>th</sup>.
