### 1. IMPACT OF COVID-19 ON THE AGM

- 1.1 The Board is aware of the ongoing public health risk and recognises that the situation in relation to the pandemic can change quickly and that social distancing requirements may make a normal meeting impractical or altogether impossible. The Board will therefore continue to monitor developments and will make changes to the arrangements for the meeting as necessary. All directors will be in attendance either in person or via teleconference, given prevailing restrictions on travel and associated quarantine requirements.

#### **EXPLANATIONS OF RESOLUTIONS**

#### Resolution 1 – Reports and Accounts

The directors of the Company are obliged to lay the Company's annual report, which incorporates the directors' report and auditors' report, and audited accounts before members at a general meeting, and this resolution approves their receipt.

## Resolutions 2 to 6 - Re-appointment of directors

Pursuant to article 85 of the articles of association of the Company, one third of the directors or, if their number is not a multiple of three, then the number nearest to but not exceeding one third, are required to retire by rotation.

Notwithstanding the provisions of the articles of association of the Company the Board has decided that, in the interest of best corporate governance practice, all of the directors shall retire and make themselves available for re-appointment.

Brief biographical details of each of the directors are set out on pages 64-66 of the Annual Report.

## Resolutions 7 and 8 – appointment of auditors and determination of auditors' remuneration

The Company is required to appoint auditors at each general meeting at which accounts are laid, to hold office until the next general meeting at which accounts are laid.

As documented in the Audit Committee section of the accompanying Annual Report & Accounts, Deloitte LLP have now completed the FY21 audit. In late 2020 Deloitte indicated to the Group that they did not wish to be put forward for reappointment at the conclusion of the FY21 audit and wanted to work with the Group to ensure a smooth transition to a successor audit firm. Therefore, over a number of months, the Audit Committee has undertaken a detailed review of alternative options in the market and, following detailed proposals and a series of presentations and workshops, have concluded that BDO LLP offer the most appropriate mix of experience, quality, geographic coverage and value for money. This assessment has been supported by verbal references given by other similar-sized companies in both the UK and US that have attested to a smooth transition from Deloitte to BDO.

Based on the work undertaken by the Audit Committee, the Board recommends that BDO LLP be appointed as the Group's auditor and this resolution proposes their appointment. Assuming that this resolution is approved, BDO LLP will undertake an orderly handover with Deloitte through 2021 in readiness for the FY22 audit.

In accordance with standard practice, resolution 8 authorises the directors to determine the level of the auditors' remuneration.

## Resolution 9 - authority to allot shares

Resolution 9.1 grants the directors of the Company authority to allot unissued share capital up to an aggregate nominal amount of £1,087,607 (representing 108,760,700 Ordinary Shares and being approximately one third of the Company's Ordinary Shares in issue at 4 August 2021.

In line with guidance issued by the Investment Association, resolution 9.2 grants the directors of the Company authority to allot unissued share capital in connection with a rights issue in favour of ordinary shareholders up to an aggregate nominal amount of £2,175,214 (representing 217,521,400 Ordinary Shares), as reduced by the nominal amount of any shares issued under resolution 9.1. This amount, before any such reduction, represents approximately two thirds of the Company's Ordinary Shares in issue at 4 August 2021.

The authorities granted by resolution 9 replace and are in substitution for existing authorities to allot shares granted to the directors of the Company and, if granted, expire at the conclusion of

the next annual general meeting of the Company or 15 months after the date of the resolution, if later.

## Resolution 10 - disapplication of statutory pre-emption rights

To give the directors some flexibility to raise capital through a non pre-emptive issue of shares, resolution 10 disapplies the statutory pre-emption rights which would otherwise apply on an issue of shares for cash and is limited to allotments in connection with rights issues or other pre-emptive offers, or otherwise up to a maximum nominal amount of £326,282 (representing 32,628,200 Ordinary Shares and being approximately 10 per cent. of the Company's Ordinary Shares in issue at 4 August 2021).

The power granted by resolution 10 replaces and is in substitution for, all existing powers to disapply statutory pre-emption rights granted to the directors of the Company and, if granted, shall expire at the conclusion of the next annual general meeting of the Company or 15 months after the date of the resolution, if later.

## Resolution 11 - purchase of own shares

Resolution 11 gives general authority for the Company to make market purchases of up to 32,628,226 Ordinary Shares (being approximately 10 per cent. of the Company's Ordinary Shares in issue at 4 August 2021). The minimum price and the method of determining the maximum price which may be paid for an ordinary share is set out in the resolution. It is not the directors' current intention to exercise this authority and the directors would only consider making purchases if they believed that such purchases would be in the best interests of shareholders generally and would result in an increase in earnings per share.
