## Capital Raising Update

Australian natural skin care company Skin Elements Limited (ASX: SKN) (the 'Company') is pleased to provide the following market update in relation to capital raising.

### Finalisation of Option Underwriting Arrangement

The Company advises that it has finalised arrangements in relation to the Underwriting Agreement dated 16 April 2020 between the Company and State Securities Pty Ltd as underwriter.

As announced to the market on 12 and 25 January 2021, the Company previously received funds through the exercise of options and shortfall applications for a total of 11,211,501 SKNOA options and 35,474,348 SKNUO options for total cash received of \$2,185,381.

As also announced on 25 January 2021 the underwriter requested an additional 7 business days to complete its obligations to subscribe for an additional 85,403,426 shares for an aggregate amount of \$8,540,342.60 pursuant to the Underwriting Agreement.

The Company has received a further \$1,200,000 in cash from the underwriter and the Company has issued a further 12,000,000 ordinary fully paid shares to the underwriter from the Company's ASX Listing Rule 7.1A placement capacity. An Appendix 2A in relation to this share issue is attached.

Subsequently, on 3 March 2021 the underwriter advised the Company that it was no longer able to fulfil its obligations for the balance of the funds due under the Underwriting Agreement due to various factors including parties who had previously committed to provide funds to the underwriter being unable to perform in a timely manner and the significant detriment caused to the underwriter's business due to the Covid pandemic in circumstances where the underwriter's business is in Victoria. The Company does not believe it is in the interests of shareholders to commit funds and management time to pursuing legal action against the underwriter with no certainty as to the length of time and amount of money legal action would entail. The Company has therefore advised the underwriter that it will not rely on its rights pursuant to the Underwriting Agreement to pursue the underwriter to fulfil its remaining obligations. The Company will not, however, be paying any fees to the underwriter pursuant to the Underwriting Agreement, as a consequence of the underwriter's failure to meet its obligations in full.

The Company and the underwriter have released each other from any further obligations pursuant to the Underwriting Agreement and there are no ongoing arrangements between the Company and the underwriter.

#### **Entitlement Issue**

The Company is pleased to announce that further to the request from shareholders at its recent Annual General Meeting, the Company will also be undertaking a non-renounceable pro rata entitlement issue at an issue price of \$0.08 per share on the basis of one (1) new shares for every fifteen (15) ordinary shares held. Shareholders who subscribe for the entitlement issue will also receive one attaching listed option for every two new shares issued, exercisable at \$0.10 and expiring 3 years after the date of issue.

Under the entitlement issue up to 25,298,484 shares and 12,649,242 attached options will be issued to raise up to \$2,023,879 (before costs).

The proposed entitlement issue is not underwritten.

An Appendix 3B in relation to the entitlement issue including an indicative timetable is attached.

Further details in relation to the entitlement issue including the entitlement issue Prospectus will be released to ASX and provided to eligible shareholders in due course.

#### **Use of funds**

The funds raised will be used by the Company to expand the marketing and production of its Invisi-Shield disinfectant range, as well as the continued commercialisation of its Soleo Organics natural sun care range and PapayaActivs therapeutic skincare range.

#### **Custodian Financing Facility**

The Company confirms that its \$10,000,000 pre-factoring finance facility with Custodian Australia Pty Ltd as previously announced to ASX remains available for drawdown.

#### **Update on voluntary suspension**

The Company's shares will remain suspended from trading until such time as the Company has responded to any ASX queries.
