## NEW ENERGY SOLAR (ASX: NEW) UNAUDITED NET ASSET VALUE AS AT 18 JUNE 2021

New Energy Solar's weekly estimated unaudited net asset value (**NAV**) as at 18 June 2021 was A\$1.23 per stapled security.

New Energy Solar's directors have elected to make this disclosure to the market to provide securityholders with additional information about changes in the estimated NAV of their stapled securities due to movements in the AUD:USD foreign exchange rate.

This weekly unaudited NAV estimate has been calculated by reference to New Energy Solar's most recently published audited NAV (being A\$1.25 per stapled security as at 31 December 2020 which applied an AUD:USD foreign exchange rate of 0.7694), adjusting for changes in the AUD:USD foreign exchange rate, distribution announced, the value of the Australian assets determined during the asset sale process and the number of stapled securities on issue since that date. Transactions costs incurred during the Australian asset sale process will not be recognised until the sale has completed. The applicable AUD:USD foreign exchange rate applied in calculating the estimated unaudited NAV as at 18 June 2021 was 0.7479.
