## FUND PAYMENT NOTICE

For the purposes of Subdivisions 12-H and 12A-B of Schedule 1 to the *Tax Administration Act 1953* this notice sets out the relevant "fund payment" components of the 2.5 cents per unit **(CPU)** to be paid by Vitalharvest Freehold Trust **(VTH)** on 14<sup>th</sup> May 2021 for the period to 31 December 2020.

The Trust Company (RE Services) Limited, the Responsible Entity for VTH, considers that VTH is a withholding Managed Investment Trust **(MIT)** and that throughout the period ending 31 December 2020 will be an Attribution MIT.

The fund payment information below is provided solely to assist other entities with withholding obligations that may arise in respect of any amounts distributed to non-residents.
