



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 25TH APRIL 2024

1. Market overview

- Today's trading session recorded a total turnover of Frw 927,947,500 from 5,016,700 shares traded in 5 deals on the equities market and Frw 20,610,000 worth of bonds traded in 2 deals on the fixed-income market.
- RSI and ALSI remained constant to close at 117.24 and 144.91 respectively.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 43,000 from 1,000 shares traded in 1 deal.
- BLR counter closed at Frw 185 (Frw 185 previous). The trading session recorded a total turnover of Frw 927,904,500 from 5,015,700 shares traded in 4 deals.

- Equities counters closed as follows: MTNR: Frw 170; BOK: Frw 300; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On MTNR counter, there were outstanding offers of 364,000 shares between Frw 170 - 174 and no bids. On IMR counter, there were outstanding offers of 116,000 shares between Frw 43 - 45 and no bids. On BLR counter, there were outstanding bids of 100,000 shares at Frw 180 and no offers

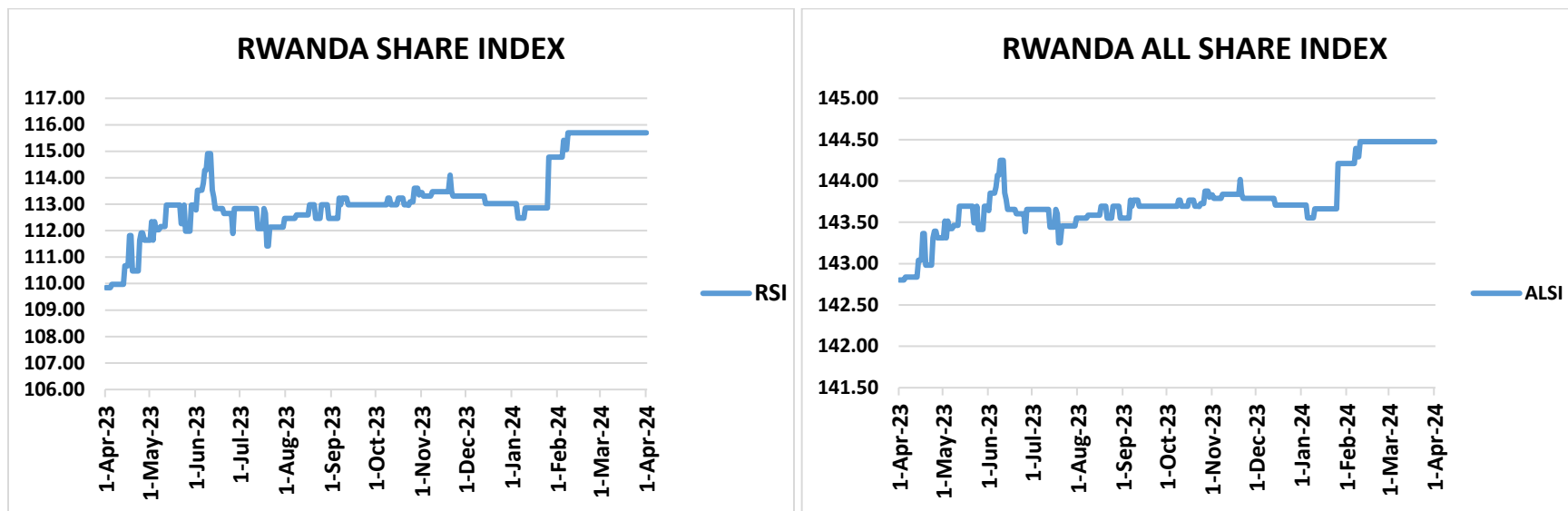
