



RWANDA STOCK EXCHANGE MARKET REPORT FOR FRIDAY 05TH APRIL 2024

1. Market overview

- Today's trading session recorded a turnover of Frw 871,158,500 traded in 7 deals on the fixed-income market and Frw 6,593,600 from 142,200 shares traded in 5 deals on the equities market.
- RSI and ALSI remained constant to close at 115.69 and 144.47 respectively.
- MTNR counter closed at Frw 170 (Frw 170 previous). The trading session recorded a total turnover of Frw 136,000 from 800 shares traded in 2 deals.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 5,977,000 from 139,000 shares traded in 1 deal.
- BLR counter closed at Frw 174 (Frw 174 previous). The trading session recorded a total turnover of Frw 330,600 from 1,900 shares traded in 1 deal.

- Equities counters closed as follows: CMR: Frw 152; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On MTNR counter, there were outstanding offers of 821,900 shares between Frw 170 - 175 and no bids. On IMR counter, there were outstanding offers of 305,800 shares between Frw 43 - 45 and no bids. On BLR counter, there were outstanding bids of 57,000 shares between Frw 174 – 180.

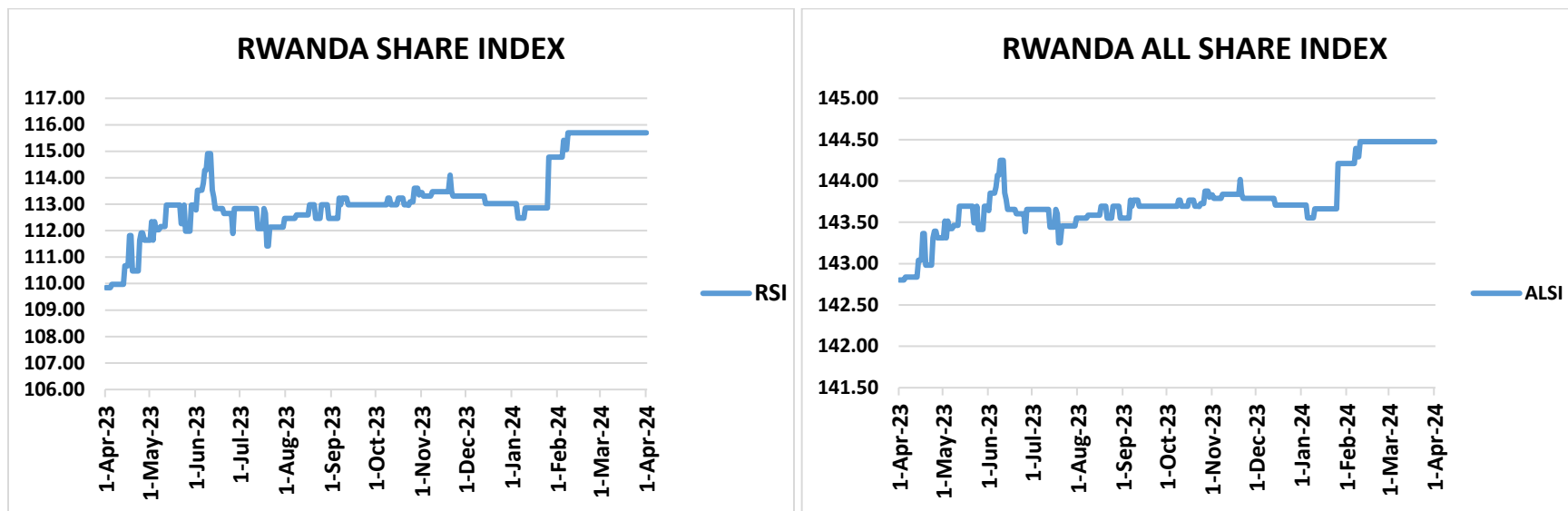

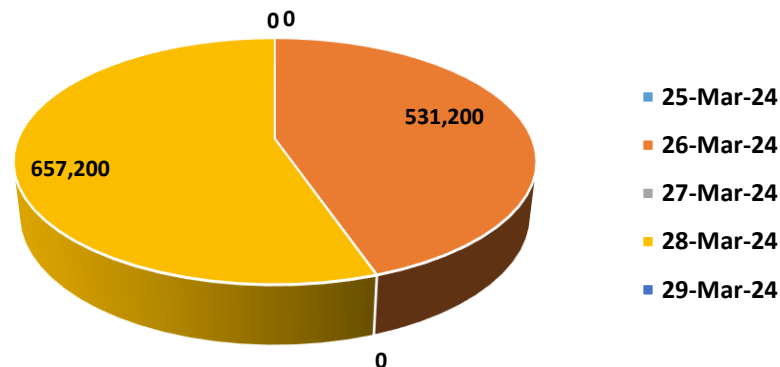

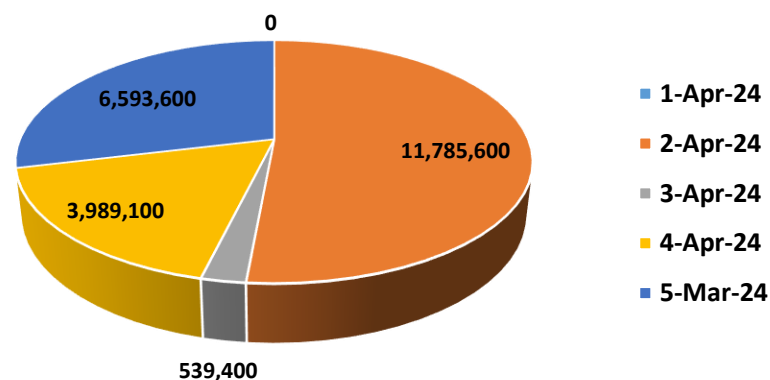
