Pursuant to the share consolidation timetable issued by Birmingham Sports Holdings Limited ("Birmingham Sports"), the share consolidation of 25 existing shares of HK\$0.01 each in Birmingham Sports into 1 consolidated share of HK\$0.25 each will become effective on 6 February 2023. Shareholders, investors and market participants should read the Birmingham Sports's circulars and regulatory announcements in full including the terms and conditions of Birmingham Sports's share consolidation in dealing with Birmingham Sports's shares. #### Adjustment Formula:

Adjusted Previous Closing Price = Closing Price on the day immediately before Share Consolidation becoming effective x R

where: R = Ratio of Share Consolidation, i.e. 25/1
