Purchase of shares in VGI Partners Asian Investments Limited (ASX:VG8)

On 9 April 2021, VGI Partners Limited ("VGI Partners") (ASX:VGI) purchased 150,000 shares in VG8 (the "Shares") to hold on its own balance sheet taking VGI's total holding in VG8 to 12,073,922 ordinary shares.

Robert Luciano is a director of VG8 and also the majority shareholder in VGI Partners.
