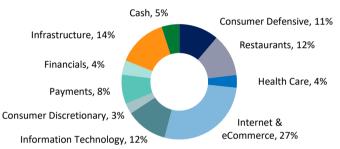

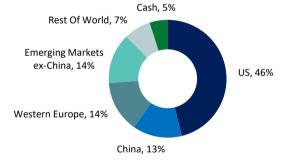

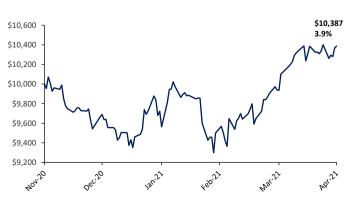
#### Sector Exposure by Source of Revenue#
