New Delhi, 17th October 2022: TRAI, with the assistance of the Telecom Service Providers, conducted Drive Tests in fifteen cities and surrounding areas viz. Jalandhar, Ambala, Aizawl, Contai, Imphal, Kishanganj, Port Blair, Bilaspur, Gwalior, Meerut, Ahmednagar, Chikmagalur, Warangal, Cuttack, Coimbatore, two highways Meerut-Agra, Gwalior-Guna and one rail route Raigarh to Dongargarh, conducted in the quarter ending June 2022.

The Drive tests were conducted to assess the network quality provided by cellular mobile telephone service providers for voice and data services. The details of drive tests conducted are given below;
