Subject: Explanation on the Change of the Major Shareholder Structure

To: The President

In reference to the Extraordinary General Meeting of shareholders of PP Prime Public Company Limited. No.1/2022 on May 11, 2022 has approved the issuance and offering of 8,517,598,284 ordinary shares at par value of Baht 1.00 per share. To the shareholders named as of the date to determine the names of shareholders who have the right to subscribe for the newly issued ordinary shares of the Company for offering to the existing shareholders in proportion to their shareholding (Record Date) May 23, 2022 ("Record Date") to the existing shareholders without allocating to shareholders that would make the company have duties under foreign law at the ratio of 1 existing shares to 3 new ordinary shares at the offering price of Baht 0.10 each in the case of fractions of share shall be rounded down. Shareholders can subscribe for newly issued ordinary shares in excess of their rights at the rate specified above (Oversubscription).

The Company has set a date for subscription and payment of the newly issued ordinary shares during 13 - 17 June 2022 with shareholders exercising their right to subscribe for shares 7,424,674,374 shares, totaling 742,467,437.40 baht,

According to Report Form 246-2 of the Office of the Securities and Exchange Commission has reported the acquisition of securities of PP Prime Public Company Limited.

On June 22, 2022, Mr. Parin Chanuntranont's group received shares from the above allotment of newly issued ordinary shares. 1,720,877,818 shares, making Mr. Parin Chanuntranont's group holding shares from 450,292,606 shares to 2,171,170,424 shares, or 21.79% resulting in a change in the shareholding structure of the Company's major shareholders.
