Q1 2024 Quarterly Activity Report & Appendix 4C

Key Highlights:

- Regulatory and commercial readiness activities progressing to schedule, with EBR on track to submit
 the final module of its Pre-Market Approval ("PMA") Application to the U.S. Food and Drug
 Administration ("FDA") in Q3 2024. The Company is targeting FDA approval in Q1 2025
- Presented EBR's positive SOLVE-CRT pivotal study results at leading global conferences, including the European Heart Rhythm Society Meeting and the 2024 Emergence Conference
- Post quarter, EBR appointed Mr Erik Strandberg as Chief Commercial Officer to lead EBR's US commercialisation strategy
- EBR officially included in the S&P/ASX All Ordinaries Index, highlighting EBR's growing presence and increasing company profile
- Well-capitalised through initial commercialisation with cash and short-term investments of US\$64.1/A\$98.4¹ million as of 31 March 2024

Sunnyvale, California; 26 April 2024: EBR Systems, Inc. (ASX: **"EBR"**, **"EBR Systems"**, or the **"Company"**), developer of the world's only wireless cardiac pacing system for heart failure, is pleased to release its Quarterly Activity Report and Appendix 4C for the March quarter (**"Q1 2024"**).

John McCutcheon, EBR Systems' President & Chief Executive Officer said:

"We have made positive strides in our regulatory and commercialisation agenda, pushing us closer towards our final PMA submission in Q3 2024. Our WiSE-CRT System has continued to feature at key industry conferences, providing a platform to showcase our technology amongst industry peers and the wider scientific community. We were also delighted to provide an update and meet with new and existing investors during our Australian roadshow, held earlier this year.

Our final regulatory and testing procedures remain on track, underpinning our confidence in achieving our Q3 2024 submission target. We remain highly focused on positioning EBR for success post-regulatory approval and ensuring WiSE CRT realises the commercial potential in which we firmly believe.

Regulatory and commercialisation activities progressing to schedule

EBR continues to progress its regulatory and commercialisation agenda, building on the positive SOLVE-CRT trial results announced in the prior year. The Company has submitted its SOLVE-CRT study dataset for publication in a peer-reviewed medical journal and intends to publish a series of additional sub-studies, revealing key findings throughout the calendar year. With EBR's Breakthrough Device Designation, along with its direct communication channel with the FDA, the Company is confident in achieving its Q3 2024 submission target of the final PMA module.

Following regulatory approval, EBR's initial commercialisation strategy will concentrate on four specific patient groups within the US market. These groups include acute lead failure, high risk upgrades, leadless upgrades, and chronic lead failure patients. To drive initial sales growth, EBR plans to leverage its partnerships with high volume CRT procedure sites developed over the course of its SOLVE-CRT trial and our established specialist sales force. Given EBR's Breakthrough Device Designation, the Company automatically qualifies for the New Technology Add-On Payment ("NTAP") and Transition Pass-Through ("TPT") reimbursement programs, enabling EBR to set an average selling price ("ASP") of ~US\$45k upon commercialisation.

Continued media and investor engagement

EBR continued to feature at distinguished investor conferences, including the Emergence 2024 Sydney Conference (28 February 2024) and the Emergence 2024 Singapore Conference held at the Marina Bay Sands in Singapore (19 March 2024). EBR management presented the Company and EBR's pivotal SOLVE-CRT results to a network of 500 Asia-based high-net-worth investors, family offices and professional investors. EBR was also 1 of 11 companies to feature and present on The Stock Network's 'ASX Gems' webcast (22 March 2024).

EBR also featured in a detailed review article published in both The Australian and Stockhead.

In January / February 2024, EBR's management team completed an Australian investor roadshow across Melbourne, Sydney, Adelaide, and Brisbane. EBR shareholders in attendance were provided with an update on the Company's recent activities and were able to receive a hands-on demonstration with EBR's technology and hear directly from a WiSE-CRT patient.

Strengthened management team

Post quarter, EBR appointed Mr Erik Strandberg as Chief Commercial Officer ("CCO") of the Company (refer to ASX release titled "EBR appoints Erik Strandberg as Chief Commercial Officer" dated 18 April 2024). Mr Strandberg has over 20 years of medical device sales industry experience with well developed relationships across a broad spectrum of physician, C-suite hospital executives and medical professionals. He has demonstrated exceptional strategic sales planning, contract negotiation, operational oversight, and leadership expertise. Prior to joining EBR, Mr Strandberg held leadership positions with AtriCure (NASDAQ:ATRC), Boston Scientific (NYSE:BSX), St Jude Medical and Guidant Corporation. Mr Strandberg's experience will be critical in leading the Company's US commercialisation strategy, overseeing WiSE's launch and driving business development activities globally.

Corporate Update

During the quarter, EBR had net operating cash outflows of US\$10.0/A\$15.3² million, mostly relating to research and development costs, staff costs, and interest costs. Payments made to related parties as described in Items 6.1 of the Appendix 4C were for Executive and Non-Executive Director renumeration. In addition to its cash balance of US\$7.7/A\$11.9² million on 31 March 2024, EBR held US\$56.4/A\$86.5² million in short-term investments which will become cash or cash equivalents in the future. Investments are made in fixed income instruments, have a weighted average maturity of 3.9 months, and have a minimum credit rating of A-2/P-2/F2 by at least two of three Nationally Recognised Statistical Rating Organisations, specifically Standard & Poor's, Moody's, or Fitch.

Lastly, EBR achieved a significant milestone with its first entry into the S&P/ASX All Ordinaries Index in March 2024. EBR's inclusion in this index increases the Company's visibility amongst investors, validates the company's strong market performance, and effectively paves the way for increased liquidity and broader investment opportunities.

About EBR Systems (ASX: EBR)

Silicon Valley-based EBR Systems (ASX: EBR) is dedicated to superior treatment of cardiac rhythm disease by providing more physiologically effective stimulation through wireless cardiac pacing. The patented proprietary Wireless Stimulation Endocardially (WiSE) technology was developed to eliminate the need for cardiac pacing leads, historically the major source of complications, effectiveness, and reliability issues in cardiac rhythm disease management. The initial product is designed to eliminate the need for coronary sinus leads to stimulate the left ventricle in heart failure patients requiring Cardiac Resynchronisation Therapy (CRT). Future products potentially address wireless endocardial stimulation for bradycardia and other non-cardiac indications.

EBR Systems' WiSE Technology

EBR Systems' WiSE technology is the world's only wireless, endocardial (inside the heart) pacing system in clinical use for stimulating the heart's left ventricle. This has long been a goal of cardiac pacing companies since internal stimulation of the left ventricle is thought to be a potentially superior, more anatomically correct pacing location. WiSE technology enables cardiac pacing of the left ventricle with a novel cardiac implant that is roughly the size of a large grain of rice. The need for a pacing wire on the outside of the heart's left ventricle – and the attendant problems – are potentially eliminated. WiSE is an investigational device and is not currently available for sale in the US.

On 30 June 2022, the Company entered into a loan and security agreement with Runway Growth Finance Corp, whereby the Company has the availability to borrow up to \$50m USD. As of 31 March 2024, the Company has borrowed \$40m USD. The Company has not met certain other requirements, which will allow the Company to borrow the remaining \$10m USD. The loan accrues interest at the Prime Rate plus 4.90%. Interest is payable on the 15th calendar day of each month, and the loan matures on 15 June 2027.

The Company has \$56.4m USD in short-term investments in addition to the \$7.7m cash and cash equivalents shown above. With \$64.1m in cash and short-term investments, the Company has 6.4 quarters of funding available. Investments are made in fixed income instruments, have a weighted average effective maturity of 3.9 months, and have a minimum credit rating of A-2/P-2/F2 by at least two of three Nationally Recognised Statistical Rating Organizations, specifically Standard & Poor's, Moody's, or Fitch.
