# Ramaco Resources, Inc. - Anticipated Distribution

## **DESCRIPTION:**

Ramaco Resources, Inc. (METC) has announced a conditional distribution of (New) Ramaco Resources, Inc. (METCB) Class B Common Shares. The distribution ratio is 0.2 of a METCB share for each METC share held. The record date is May 12, 2023; the payable date is June 12, 2023. The ex-distribution date has yet to be determined. In connection with the distribution, and as a condition to the distribution, METC Common Shares will be reclassified as Class A Common Stock. The reclassification and distribution are subject to shareholder approval at the METC special meeting on June 12, 2023.

Ramaco Resources, Inc. Class B Common Shares are expected to trade on the Nasdaq Stock Market under the trading symbol "METCB".
