FINAL CONTRACT ADJUSTMENT Westshore Terminals Investment Corporation (WTE) Special Cash Dividend

The Bourse and CDCC wish to inform you that the Directors of Westshore Terminals Investment Corporation (the "**Corporation**"), declared on March 8, 2024, a special cash dividend of CAD \$0.35 per common share. The special dividend will be paid on April 15, 2024 to shareholders of record as of the close of business on March 31, 2024. The ex-dividend date is March 27, 2024.

The Bourse and CDCC will take into account the special dividend by adjusting the strike prices of Westshore Terminals Investment Corporation (WTE) options, by an amount equivalent to the special dividend that is CAD \$0.35.

Special Dividend - Adjustment Details:

- **EX-DATE:** **March 27, 2024**
- **RECORD DATE:** **March 31, 2024 (Sunday)**
- **PAYABLE DATE:** **April 15, 2024**

CDCC - Adjustment Details:

According to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Westshore Terminals Investment Corporation (WTE) options will be adjusted as follows:

- **EFFECTIVE :** **March 27, 2024**
- **OPTIONS SYMBOL:** **Unchanged**
- **NUMBER OF CONTRACTS:** **Unchanged**
- **MULTIPLIER:** **Unchanged**

- **DELIVERABLE PER CONTRACT:** 100 common shares of WTE
- **POSITION AND EXERCISE LIMITS:** Position and exercise limits will remain unchanged at 50 000 contracts.
- **CUSIP:** Unchanged
- **STRIKE PRICES:** An adjustment of CAD \$0.35 will be made for all existing series.
