Providing for consideration of the bill (H.R. 4365) making appropriations for the Department of Defense for the fiscal year ending September 30, 2024, and for other purposes; providing for consideration of the bill (H.R. 1130) to repeal restrictions on the export and import of natural gas; and providing for consideration of the resolution (H. Res. 684) condemning the actions of Governor of New Mexico, Michelle Lujan Grisham, for subverting the Second Amendment to the Constitution and

- 13 or their respective designees. After general debate the bill
- 14 shall be considered for amendment under the five-minute

- 18 and import of natural gas. The first reading of the bill
- 19 shall be dispensed with. All points of order against consid-
