A BILL

To direct the Secretary of Homeland Security to issue guidance with respect to certain information and communications technology or services contracts, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “DHS Software Supply*
5 *Chain Risk Management Act of 2021”.*

6 **SEC. 2. DEPARTMENT OF HOMELAND SECURITY GUIDANCE**

7 **WITH RESPECT TO CERTAIN INFORMATION**

8 **AND COMMUNICATIONS TECHNOLOGY OR**

9 **SERVICES CONTRACTS.**

10 *(a) GUIDANCE.—The Secretary of Homeland Security,*
11 *acting through the Under Secretary, shall issue guidance*
12 *with respect to new and existing covered contracts.*

13 *(b) NEW COVERED CONTRACTS.—In developing guid-*
14 *ance under subsection (a), with respect to each new covered*
15 *contract, as a condition on the award of such a contract,*
16 *each contractor responding to a solicitation for such a con-*
17 *tract shall submit to the covered officer—*

18 *(1) a planned bill of materials when submitting*
19 *a bid proposal; and*

20 *(2) the certification and notifications described*
21 *in subsection (e).*

22 *(c) EXISTING COVERED CONTRACTS.—In developing*
23 *guidance under subsection (a), with respect to each existing*
24 *covered contract, each contractor with an existing covered*
25 *contract shall submit to the covered officer—*

1 (1) *the bill of materials used for such contract,*
2 *upon the request of such officer; and*

3 (2) *the certification and notifications described*
4 *in subsection (e).*

5 (d) *UPDATING BILL OF MATERIALS.*—*With respect to*
6 *a covered contract, in the case of a change to the informa-*
7 *tion included in a bill of materials submitted pursuant to*
8 *subsections (b)(1) and (c)(1), each contractor shall submit*
9 *to the covered officer the update to such bill of materials,*
10 *in a timely manner.*

11 (e) *CERTIFICATION AND NOTIFICATIONS.*—*The certifi-*
12 *cation and notifications referred to in subsections (b)(2)*
13 *and (c)(2), with respect to a covered contract, are the fol-*
14 *lowing:*

15 (1) *A certification that each item listed on the*
16 *submitted bill of materials is free from all known*
17 *vulnerabilities or defects affecting the security of the*
18 *end product or service identified in—*

19 (A) *the National Institute of Standards and*
20 *Technology National Vulnerability Database;*
21 *and*

22 (B) *any database designated by the Under*
23 *Secretary, in coordination with the Director of*
24 *the Cybersecurity and Infrastructure Security*
25 *Agency, that tracks security vulnerabilities and*

1 defects in open source or third-party developed
2 software.

3 (2) A notification of each vulnerability or defect
4 affecting the security of the end product or service, if
5 identified, through—

6 (A) the certification of such submitted bill
7 of materials required under paragraph (1); or

8 (B) any other manner of identification.

9 (3) A notification relating to the plan to miti-
10 gate, repair, or resolve each security vulnerability or
11 defect listed in the notification required under para-
12 graph (2).

13 (f) *ENFORCEMENT.*—In developing guidance under
14 subsection (a), the Secretary shall instruct covered officers
15 with respect to—

16 (1) the processes available to such officers enforce-
17 ing subsections (b) and (c); and

18 (2) when such processes should be used.

19 (g) *EFFECTIVE DATE.*—The guidance required under
20 subsection (a) shall take effect on the date that is 180 days
21 after the date of the enactment of this section.

22 (h) *GAO REPORT.*—Not later than 1 year after the
23 date of the enactment of this Act, the Comptroller General
24 of the United States shall submit to the Secretary, the Com-
25 mittee on Homeland Security of the House of Representa-

1 *tives, and the Committee on Homeland Security and Gov-*
2 *ernmental Affairs of the Senate a report that includes—*

3 *(1) a review of the implementation of this sec-*
4 *tion;*

5 *(2) information relating to the engagement of the*
6 *Department of Homeland Security with industry;*

7 *(3) an assessment of how the guidance issued*
8 *pursuant to subsection (a) complies with Executive*
9 *Order 14208 (86 Fed. Reg. 26633; relating to improv-*
10 *ing the nation’s cybersecurity); and*

11 *(4) any recommendations relating to improving*
12 *the supply chain with respect to covered contracts.*

13 *(i) DEFINITIONS.—In this section:*

14 *(1) BILL OF MATERIALS.—The term “bill of ma-*
15 *terials” means a list of the parts and components*
16 *(whether new or reused) of an end product or service,*
17 *including, with respect to each part and component,*
18 *information relating to the origin, composition, integ-*
19 *egrity, and any other information as determined appro-*
20 *priate by the Under Secretary.*

21 *(2) COVERED CONTRACT.—The term “covered*
22 *contract” means a contract relating to the procure-*
23 *ment of covered information and communications*
24 *technology or services for the Department of Home-*
25 *land Security.*

1 (3) *COVERED INFORMATION AND COMMUNICA-*
2 *TIONS TECHNOLOGY OR SERVICES.*—The term “cov-
3 *ered information and communications technology or*
4 *services” means the terms—*

5 (A) “*information technology*” (as such term
6 is defined in section 11101(6) of title 40, United
7 States Code);

8 (B) “*information system*” (as such term is
9 defined in section 3502(8) of title 44, United
10 States Code);

11 (C) “*telecommunications equipment*” (as
12 such term is defined in section 3(52) of the Com-
13 munications Act of 1934 (47 U.S.C. 153(52)));
14 and

15 (D) “*telecommunications service*” (as such
16 term is defined in section 3(53) of the Commu-
17 nications Act of 1934 (47 U.S.C. 153(53))).

18 (4) *COVERED OFFICER.*—The term “covered offi-
19 *cer” means—*

20 (A) *a contracting officer of the Department;*
21 and

22 (B) *any other official of the Department as*
23 *determined appropriate by the Under Secretary.*

1 (5) *SOFTWARE*.—*The term “software” means*
2 *computer programs and associated data that may be*
3 *dynamically written or modified during execution.*

4 (6) *UNDER SECRETARY*.—*The term “Under Sec-*
5 *retary” means the Under Secretary for Management*
6 *of the Department of Homeland Security.*
