

**Investment in Nissay Foreign Equity Climate and Nature Transition Strategy Fund**

Nippon Life Insurance Company (President: Hiroshi Shimizu, hereinafter "Nippon Life") has invested 20 billion yen in Nissay Foreign Equity Climate and Nature Transition Strategy Fund (hereinafter "the fund"), managed by Nissay Asset Management Corporation (President: Hiroshi Ozeki).\*

The fund, which aims to realize a sustainable society and increase the corporate value of investee companies, will not only invest in companies that face challenges in terms of responding to climate change and protecting natural capital, but will also promote their efforts that contribute to solving challenges through engagement. Specifically, the fund will invest in "companies that are willing to work on such topics but have difficulties in solving them due to strategic and operational challenges" and "companies that are expected to solve challenges and increase the corporate value through engagement", utilizing investment advice provided by Nordea Asset Management Holding AB, that has extensive knowledge and expertise in responsible investment. In addition to Nippon Life, Aioi Nissay Dowa Insurance Co., Ltd. (President: Keisuke Niiro) also invests in the fund.

Nippon Life will continue to make efforts to enhance responsible investment and contribute to solving social issues.
