FCOJ Futures Daily Price Limit Reverts to 10 Cents Per Pound

Effective with the start of trading for Wednesday, March 20, 2024, the Daily Price Limit for all FCOJ futures contract delivery months subject to a limit will revert to 10 cents per pound above and below the prior day Settlement Price for the respective delivery month.
