## RECKON.AI IS THE FIRST STARTUP TO BE TARGETED FOR INVESTMENT BY THE NOS 5G FUND

- **The NOS 5G Fund led the round of seed investment in the startup company Reckon.AI with a sum of 1.5 million euros**
- **The Portuguese technology company is developing artificial intelligence and computer vision solutions applied to the retail sector**
- **5G will bring significant improvements to the company's business model, ensuring greater flexibility, efficiency and scalability**

The NOS 5G Fund, managed by Armilar Venture Partners, made its debut in startup investments with business models supported by 5G and led, in conjunction with Portugal Ventures, the round of seed capital in the Portuguese technology company Reckon.ai to a total of 1.5 million euros, which also involved the Portuguese investors Bright Pixel and WiseNext.

With an initial share capital of 10 million euros and an estimated investment period of five years, the NOS 5G Fund is the first in Portugal focused on new mobile technology. Its goal is to invest in innovative technological solutions, ranging from network infrastructure to products and solutions for customers, giving priority to technology projects in their first phase of development.

Reckon.ai, the first startup targeted for investment by the NOS 5G Fund, is a Portuguese technology startup based in Porto, which develops artificial intelligence and computer vision solutions applied to the retail sector. Founded in 2017 by Ana Pinto (CEO) and Paulo Ribeiro (CTO), it is currently developing its technology for automated retail and, with its "BuyBye" solution, has made the grab-and-go concept a reality for making stand alone and automated purchases.

The solution, based on computer vision technology, consists of a display showcase that combines cameras with load sensors to obtain images and changes in weight on the shelves in order to work out all the movements of products on sale. The showcase has a door, controlled by the system and which can be unlocked through an app, used to identify the customer and process payment.

Jorge Graça, CTO of NOS, highlights the fact that *"the investment in Reckon.ai is a historic milestone for the NOS5G Fund, the only one in Portugal set up to support technology startups that make the utmost of the potential of fifth generation mobile communications. We are really excited to be supporting Reckon.ai to develop its highly innovative solutions, which we know will benefit hugely from the introduction of 5G"*.

Ana Pinto, CEO and Co-founder of Reckon.ai, says that *"the closure of this round of seed investment means that Reckon can enter a new phase of growth. We believe that the group of investors that we have bought together will help us drive the growth of the business very rapidly, enabling us to reach the priority markets identified in our strategy, in which this kind of technology is adopted to a greater degree. NOS is a crucial partner for our technology strategy, and we are very enthusiastic to be able to count on its support and know-how in 5G, which will enable us to take our solution to another level"*.
