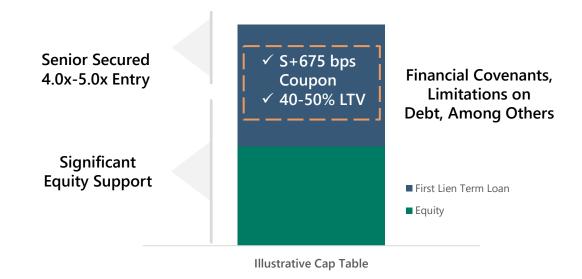

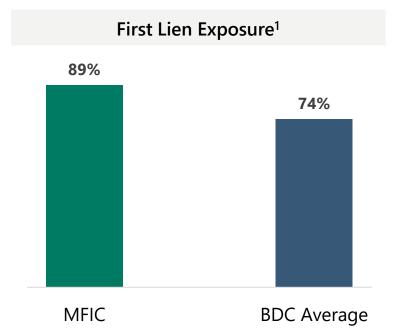

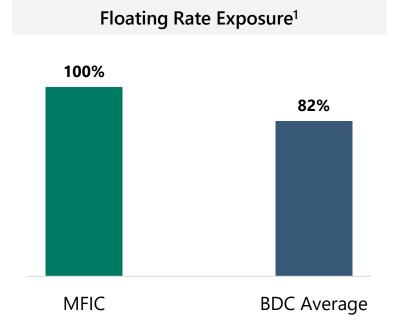

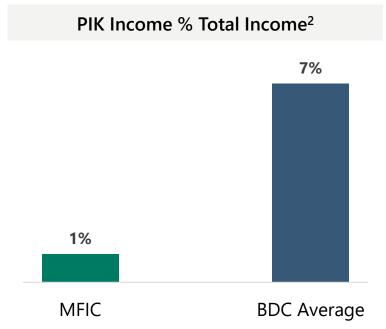
3 MFIC Compares Favorably to the BDC Averages on Select Key Metrics

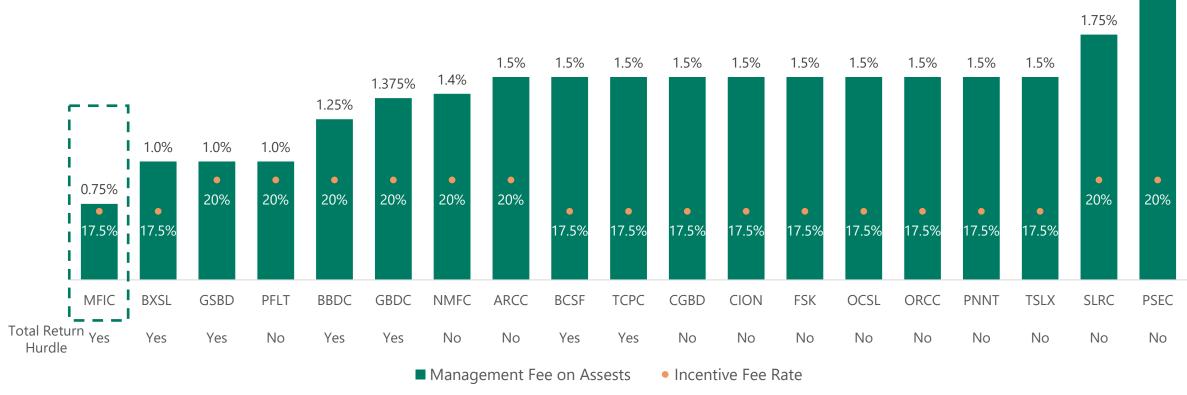

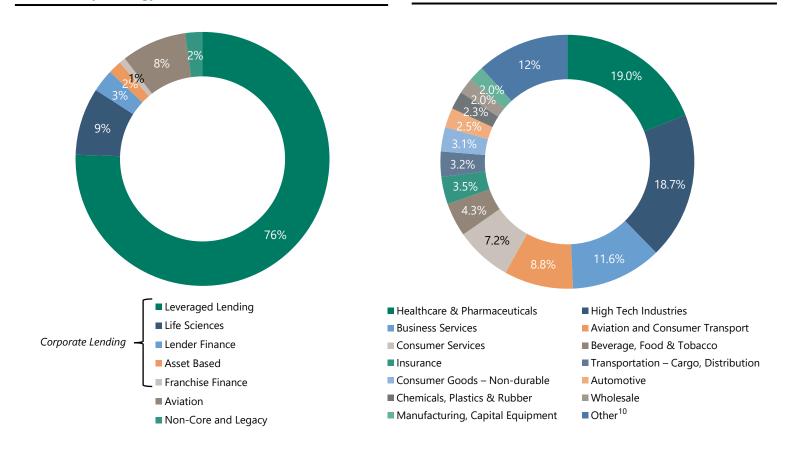

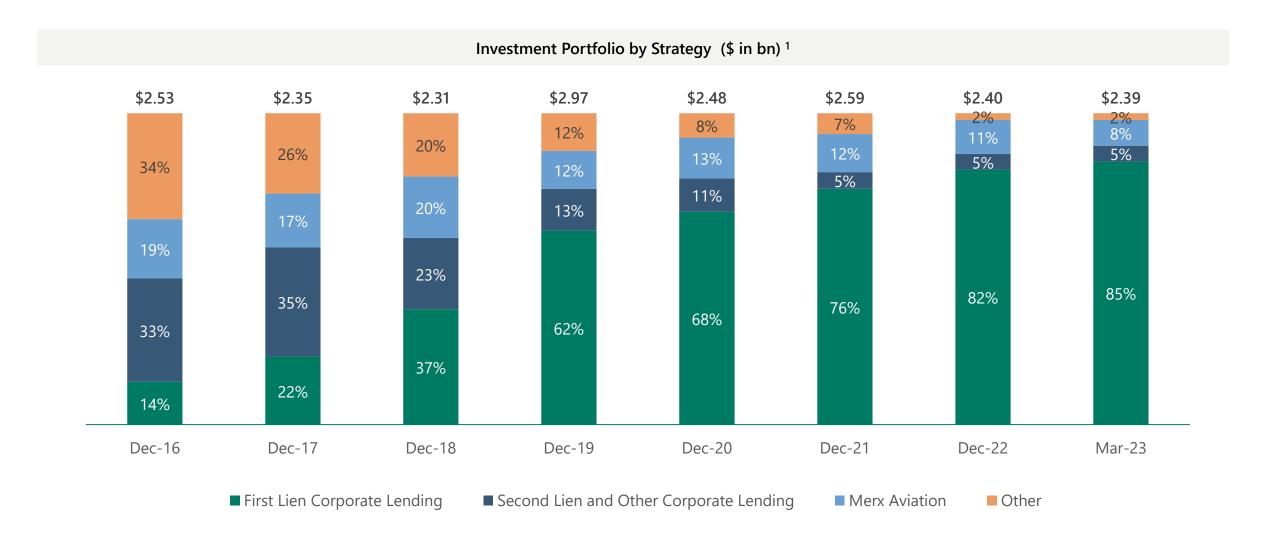

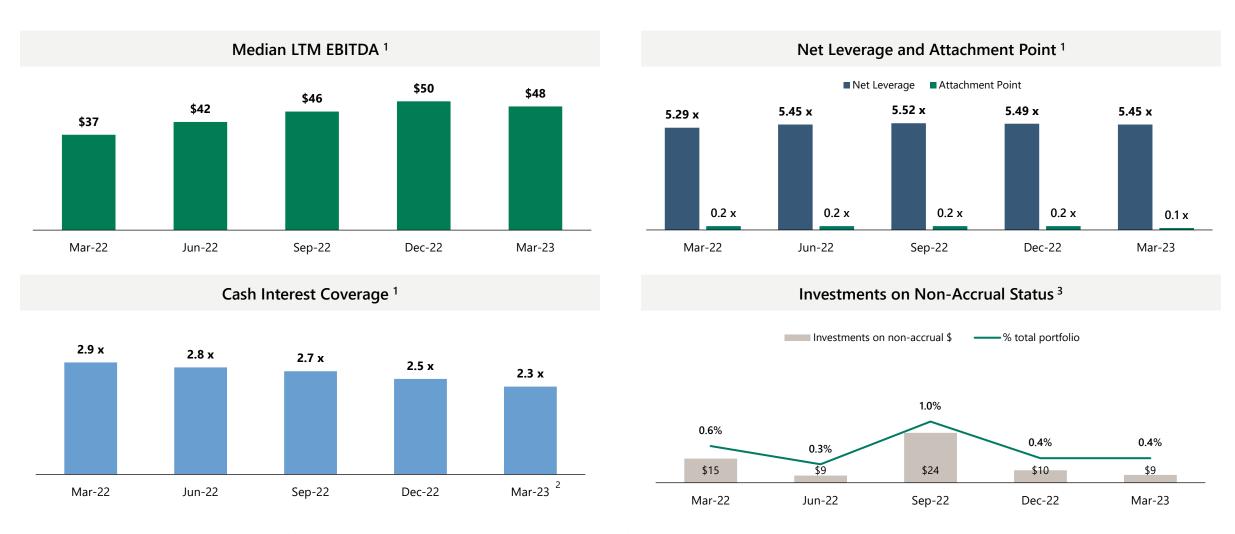

Ryan Del Giudice Chief Compliance Officer

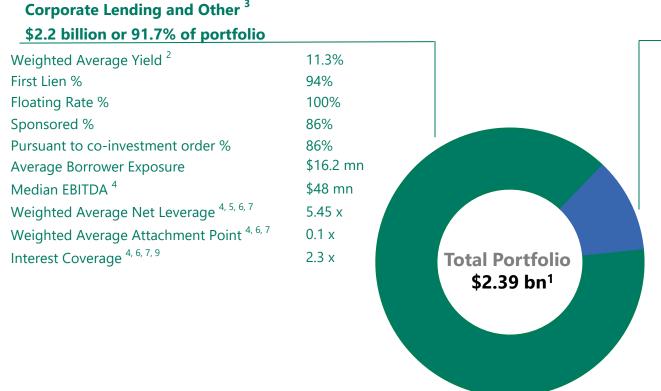

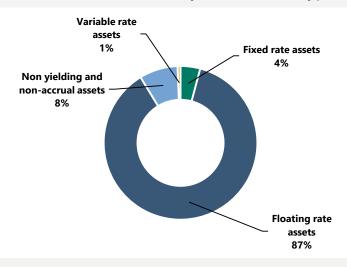

Interest Rate Exposure as of March 31, 2023

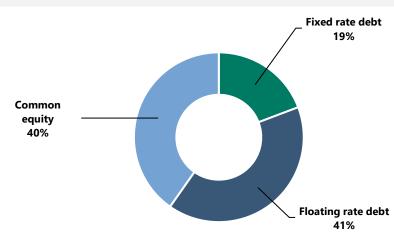
Investment Portfolio by Interest Rate Type

Net Investment Income Interest Rate Sensitivity

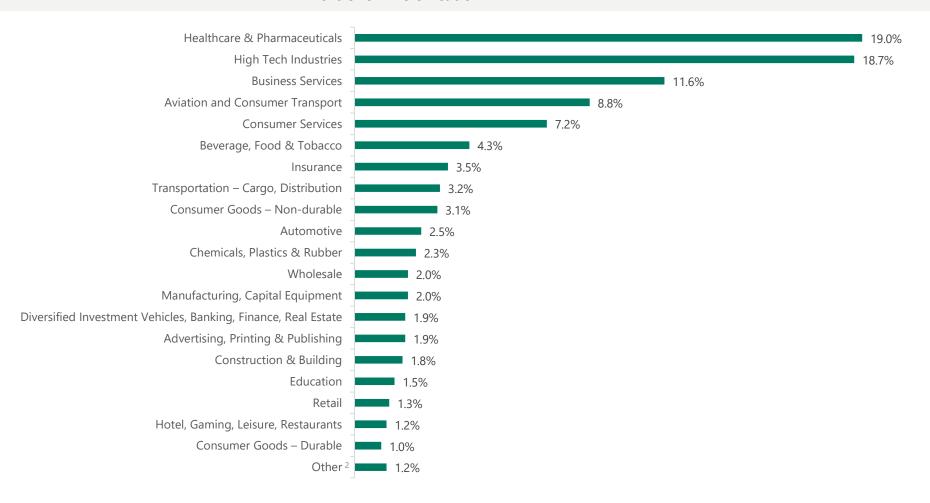
