The Newcrest ShareMatch Plan (**Plan**) provides eligible employees of Newcrest Group with an opportunity to sacrifice up to a specified amount of their salary per financial year to acquire fully paid ordinary shares in Newcrest (**shares**).

Newcrest will match an employee's contribution up to a specified amount by granting one right for each share acquired under the salary-sacrifice arrangements. Each right is a right to receive a share at the end of a restriction period, subject to the employee remaining employed by Newcrest group and satisfactory performance.

The shares and rights acquired under the Plan are subject to a 3-year restriction period during which the shares and rights are subject to dealing restrictions. The shares acquired under the Plan cannot be forfeited and will be released early if the employee ceases employment before the restriction period ends. Pro-rata vesting of rights may occur on cessation of employment in certain circumstances.

The shares will be held in Newcrest's share plan trust and will carry the same rights as other shares, including voting and dividend rights.

Allocations of shares and rights under the plan are generally made quarterly, subject to securities trading restrictions. Employees will continue to participate in the Plan until they withdraw their participation, they are promoted to a particular level, their employment ceases or the Plan is terminated by Newcrest.

The Board may exercise its discretion to allow all or some unvested Rights to vest if a change of control event occurs.

The clawback treatment set out on page 93 of the 2020 Annual Report (<a href="https://www.newcrest.com/sites/default/files/2020-10/201005\_Newcrest%20Annual%20Report.pdf">https://www.newcrest.com/sites/default/files/2020-10/201005\_Newcrest%20Annual%20Report.pdf</a>) applies to the rights (but not the shares) allocated under the Plan.
