## INPEX Announces Organizational Changes and Associated Personnel Changes

**TOKYO, JAPAN** - <u>INPEX CORPORATION</u> ("INPEX") announced today a series of organizational changes and associated personnel appointments at the General Manager level as described below, effective January 1, 2022. The organizational changes and associated personnel appointments are aimed at building a framework to achieve the goals outlined in the company's "<u>Business Development Strategy – Towards a Net Zero Carbon Society by 2050</u>" announced in January 2021 as well as implement the next medium-term management plan, and to create a functional corporate framework in line with the current business environment.

- 1. Overview
  - 1) Establishment of "Hydrogen & CCUS Development Division"
    - The current "Hydrogen & CCUS Development Unit" will be restructured into the "Hydrogen & CCUS Development Division" to further promote the clean development and supply of oil and natural gas. The Hydrogen & CCUS Development Division will consist of the "Projects Development Unit" and "Technical Planning & Development Unit."
  - Establishment of "Europe & Middle East Projects Division"
    The current "Eurasia, Middle East & Africa Projects Division" will be renamed as the "Europe & Middle East Projects Division" to reflect the positioning of Europe as a core

E&P business region following the expansion of the Norwegian business.

- Reorganization of "Americas Projects Division"
  The current "Americas Projects Division" will be restructured into the "Americas Projects Unit" to concentrate management resources on the North American business.
- 4) Establishment of "Marine Transportation Unit" The "Marine Transportation Unit" will be newly established to consolidate transportation-related operations supporting international transactions in crude oil and LNG, and to plan and implement new transportation businesses, etc.


