## **Inflasi Malaysia kekal 1.8 peratus pada Mac 2024**

**PUTRAJAYA, 25 April 2024** - Inflasi Malaysia kekal 1.8 peratus pada Mac 2024 dengan mata indeks mencatatkan 132.2 berbanding 129.9 pada bulan yang sama tahun sebelumnya. Jabatan Perangkaan Malaysia (DOSM) melaporkan hari ini mengenai keluaran **INDEKS HARGA PENGGUNA (IHP), MAC 2024**.

Peningkatan inflasi pada Mac 2024 telah didorong oleh Perumahan, Air, Elektrik, Gas & Bahan Api Lain (3.0%); Restoran & Perkhidmatan Penginapan (3.0%); Penjagaan Diri, Perlindungan Sosial & Pelbagai Barang & Perkhidmatan (2.6%) dan Pengangkutan (1.3%). Namun begitu, peningkatan ini telah diimbangi dengan kumpulan utama yang merekodkan peningkatan lebih perlahan iaitu Kesihatan (2.1%); Makanan & Minuman (1.7%) dan Rekreasi, Sukan & Kebudayaan (1.5%).

Ketua Perangkawan Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin turut berkata, peningkatan 3.0 peratus berbanding 2.7 peratus pada Februari 2024 bagi Perumahan, Air, Elektrik, Gas & Bahan Api Lain disumbangkan oleh kelas perbelanjaan Bekalan air yang meningkat kepada 31.4 peratus pada Mac 2024 (Februari 2024: 28.8%). Negeri Kedah telah menaikkan kadar tarif perkhidmatan bekalan air bagi kategori pengguna domestik bermula Mac 2024 berbanding negeri lain yang telah melaksanakan kadar tarif baharu pada Februari 2024.

Kumpulan Makanan & Minuman yang menyumbang 29.8 peratus daripada keseluruhan wajaran IHP mencatatkan peningkatan lebih rendah iaitu 1.7 peratus

pada Mac 2024 (Februari 2024: 1.9%). Subkumpulan utama Makanan di rumah meningkat 0.3 peratus pada bulan Mac 2024 (Februari 2024: 0.5%). Sementara itu, subkumpulan utama Makanan di luar rumah meningkat kepada 3.5 peratus, kadar yang sama direkodkan pada Februari 2024.

Inflasi kelas perbelanjaan Bijirin & produk bijirin meningkat kepada 2.0 peratus pada Mac 2024 (Februari 2024: 2.5%). Ini disumbang oleh Beras basmati yang meningkat perlahan 0.4 peratus berbanding 1.0 peratus pada Februari 2024. Manakala, Tepung beras meningkat kepada 9.6 peratus (Februari 2024: 8.8%).

Inflasi kelas perbelanjaan Susu, produk tenuu lain & telur mencatatkan peningkatan perlahan 1.4 peratus pada bulan Mac 2024 (Februari 2024: 2.3%). Kenaikan yang lebih rendah telah dicatatkan oleh item perbelanjaan Susu segar 2.4 peratus (Februari 2024: 2.5%). Sementara itu, inflasi bagi kelas perbelanjaan Minyak & lemak kekal pada jajaran negatif iaitu negatif 0.1 peratus pada Mac 2024 (Februari 2024: -0.2%).

Inflasi bagi kelas perbelanjaan Daging meningkat perlahan kepada 0.2 peratus pada bulan Mac 2024 (Februari 2024: 0.5%). Daging ayam segar yang merupakan komponen terbesar merangkumi 32.6 peratus dalam kelas perbelanjaan Daging mencatatkan penurunan kepada negatif 1.1 peratus (Februari 2024: -0.7%). Purata harga Ayam standard di peringkat Malaysia pada Mac 2024 adalah RM10.28 sekilogram berbanding RM10.40 sekilogram pada bulan Mac 2023 (Februari 2024: RM10.29).

Kenaikan bagi inflasi Restoran & Perkhidmatan Penginapan kepada 3.0 peratus (Februari 2024: 2.9%) disebabkan oleh peningkatan Perkhidmatan penyediaan minuman 3.7 peratus (Februari 2024: 3.4%). Dalam masa yang sama, inflasi Penjagaan Diri, Perlindungan Sosial & Pelbagai Barang & Perkhidmatan mencatatkan peningkatan 2.6 peratus (Februari 2024: 2.5%) didorong oleh peningkatan subkumpulan Barang peribadi lain, 9.8 peratus (Februari 2024: 8.6%). Selain itu, inflasi Pengangkutan pula meningkat 1.3 peratus pada Mac 2024 berbanding 1.2 peratus pada Februari 2024. Peningkatan tersebut disumbang oleh subkumpulan utama Pengurusan peralatan pengangkutan persendirian yang

meningkat kepada 1.4 peratus pada Mac 2024 (Februari 2024: 1.3%). Purata harga petrol tanpa plumbum RON97, harga yang ditetapkan pada bulan Mac 2024 adalah RM3.47 seliter berbanding RM3.35 seliter pada bulan Mac 2023 (Februari 2024: RM3.47).

Ketua Perangkawan Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin turut berkata, berhubung dengan inflasi di peringkat negeri, kebanyakan negeri merekodkan peningkatan di bawah paras inflasi nasional 1.8 peratus. Walau bagaimanapun, lima negeri merekodkan peningkatan melebihi paras inflasi nasional iaitu Pulau Pinang (3.0%), Sarawak (2.9%), Pahang (2.1%), Selangor (2.1%) dan Perlis (1.9%). Kesemua negeri mencatatkan peningkatan inflasi Makanan & Minuman. Peningkatan tertinggi dicatatkan oleh Selangor (3.2%), diikuti oleh Pulau Pinang (2.8%), Wilayah Persekutuan Putrajaya (2.6%), Sarawak (2.1%), Perlis (2.1%) dan Wilayah Persekutuan Labuan (2.0%). Sementara itu, negeri-negeri lain menunjukkan peningkatan di bawah paras inflasi Makanan & Minuman nasional iaitu 1.7 peratus pada Mac 2024.

Inflasi keseluruhan secara bulanan merekodkan kenaikan marginal 0.1 peratus berbanding 0.5 peratus yang telah dicatatkan pada Februari 2024. Antara kumpulan utama yang mencatatkan peningkatan secara bulanan ialah Restoran & Perkhidmatan Penginapan (0.4%); Penjagaan Diri, Perlindungan Sosial & Pelbagai Barang & Perkhidmatan (0.4%) dan Perumahan, Air, Elektrik, Gas & Bahan Api Lain (0.3%). Sementara itu, inflasi bagi suku tahun pertama 2024 mencatatkan peningkatan 1.7 peratus (ST4 2023: 1.6%). Bagi perbandingan suku tahunan, inflasi Malaysia mencatatkan peningkatan 0.7 peratus (ST4 2023: 0.2%). Sementara itu, inflasi teras meningkat pada kadar yang perlahan iaitu 1.7 peratus berbanding 1.8 peratus pada bulan Februari 2024. Peningkatan ini didorong terutamanya oleh kumpulan utama Makanan & Minuman dan Restoran & Perkhidmatan Penginapan yang kedua-duanya mencatatkan 3.0 peratus pada Mac 2024.

Bagi perbandingan inflasi dengan negara-negara terpilih, inflasi di Malaysia (1.8%) adalah lebih rendah berbanding Vietnam (4.0%), Filipina (3.7%), Amerika Syarikat (3.5%), Republik Korea (3.1%) dan Indonesia (3.1%). Namun, kadar tersebut lebih tinggi berbanding China (0.1%) dan Thailand (-0.5%).


**Inflasi Keseluruhan Malaysia, Januari 2011 - Mac 2024**




**Inflasi bagi Kumpulan Pendapatan Bawah RM3,000, Mac 2023 - Mac 2024**



**Inflasi mengikut Kuadran, Februari 2024 & Mac 2024**










**Inflasi bagi Makanan & Minuman, Mac 2023 - Mac 2024**




**Inflasi bagi Negara Terpilih, Mac 2023 – Mac 2024**

***Malaysia's inflation remained at 1.8 per cent in March 2024***

**PUTRAJAYA, 25 April 2024** – Malaysia's inflation remained at 1.8 per cent in March 2024 with the index points recorded at 132.2 as against 129.9 in the same month of the previous year. The Department of Statistics Malaysia (DOSM) reported today on the release of **CONSUMER PRICE INDEX (CPI), MARCH 2024**.

The increase of inflation in March 2024 was driven by Housing, Water, Electricity, Gas & Other Fuels (3.0%); Restaurant & Accommodation Services (3.0%); Personal Care, Social Protection & Miscellaneous Goods & Services (2.6%) and Transport (1.3%). However, the increase has been offset by the other main group which recorded a slower increase namely Health (2.1%); Food & Beverages (1.7%) and Recreation, Sport & Culture (1.5%).

Chief Statistician Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin said, the increase of 3.0 per cent as compared to 2.7 per cent in February 2024 for Housing, Water, Electricity, Gas & Other Fuels was contributed by the expenditure class of Water supply which increased to 31.4 per cent in March 2024 (February 2024: 28.8%). Kedah has increased the water tariff rates for domestic category users starting in March 2024 as compared to other states that have implemented the new tariff rates in February 2024.

The Food & Beverages group which contributes 29.8 per cent of the total CPI weight recorded a slower increase of 1.7 per cent in March 2024 (February 2024: 1.9%). The main subgroup of Food at home increased to 0.3 per cent

in March 2024 (February 2024: 0.5%). Meanwhile, the main subgroup of Food away from home increased 3.5 per cent, the same rate as registered in February 2024.

The expenditure class of Cereals & cereal products increased by 2.0 per cent in March 2024 (February 2024: 2.5%). This was contributed by Basmati rice which increased slower at 0.4 per cent as compared to 1.0 per cent in February 2024. Meanwhile, Rice flour inclined to 9.6 per cent (February 2024: 8.8%).

The inflation for the expenditure class of Milk, other dairy products & eggs registered a slower increase of 1.4 per cent in March 2024 (February 2024: 2.3%). The slower increase was recorded by expenditure item of Fresh milk 2.4 per cent (February 2024: 2.5%). Meanwhile, the inflation for the expenditure class of Oil & fats remained in the negative range at negative 0.1 per cent in March 2024 (February 2024: -0.2%).

The inflation for the expenditure class of Meat increased slower to 0.2 per cent in March 2024 (February 2024: 0.5%). Chicken as the largest component comprised of 32.6 per cent in the expenditure class of Meat recorded a decline of negative 1.1 per cent (February 2024:-0.7%). The average price of Standard chicken at Malaysia and in March 2024 was RM10.28 per kilogramme as compared to RM10.40 per kilogramme in March 2023 (February 2024: RM10.29).

The increase in inflation for Restaurant & Accommodation Services to 3.0 per cent (February 2024: 2.9%) due to the increase in Beverage preparation services, 3.7 per cent (February 2024: 3.4%). At the same time, inflation for Personal Care, Social Protection & Miscellaneous Goods & Services increased by 2.6 per cent (February 2024: 2.5%) due to the incline in the subgroup of Other personal item, 9.8 per cent (February 2024: 8.6%).

Other than that, inflation for Transport increased by 1.3 per cent in March 2024 as compared to 1.2 per cent in February 2024. The increase was due to the main subgroup of Operation of personal transport equipment which increased to 1.4 per cent in March 2024 (February 2024: 1.3%). The average price of Unleaded

*petrol RON97 in March 2024 was RM3.47 per litre as against RM3.35 per litre in March 2023 (February 2024: RM3.47).*

*Chief Statistician Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin also said, with regards to inflation at the state level, most of the states recorded increases below the national inflation level of 1.8 per cent. However, five states recorded increases above the national inflation level namely Pulau Pinang (3.0%), Sarawak (2.9%), Pahang (2.1%), Selangor (2.1%) and Perlis (1.9%). All states registered an increase in the inflation of Food & Beverages. The highest increase was recorded by Selangor (3.2%), followed by Pulau Pinang (2.8%), Wilayah Persekutuan Putrajaya (2.6%), Sarawak (2.1%), Perlis (2.1%) and Wilayah Persekutuan Labuan (2.0%). Meanwhile, other states showed an increase below the national inflation of Food & Beverages of 1.7 per cent in March 2024.*

*Overall, monthly inflation recorded a marginal increase of 0.1 per cent as compared to 0.5 per cent recorded in February 2024. A few main groups that posted increases on a monthly basis were Restaurant & Accommodation Services (0.4%); Personal Care, Social Protection & Miscellaneous Goods & Services (0.4%) and Housing, Water, Electricity, Gas & Other Fuels (0.3%). Meanwhile, inflation for the first quarter of 2024 recorded an incline of 1.7 per cent (Q4 2023: 1.6%). For quarterly comparison, Malaysia's inflation increased 0.7 per cent (Q4 2023: 0.2%). Meanwhile, core inflation increased slower at 1.7 per cent as compared to 1.8 per cent in February 2024. The increase was due to the Food & Beverages and Restaurant & Accommodation Services which both recorded increases of 3.0 per cent respectively in March 2024.*

*In comparison to inflation in other selected countries, inflation in Malaysia (1.8%) was lower than inflation in Vietnam (4.0%), Philippines (3.7%), United States of America (3.5%), Republic of Korea (3.1%) and Indonesia (3.1%). However, the rate is higher than China (0.1%) and Thailand (-0.5%).*




**Malaysia Headline Inflation, January 2011 - March 2024**



Note: \* Average inflation for the period of January 2011 to March 2024



**Malaysia Headline Inflation, Core Inflation and Inflation without Fuel, March 2023 - March 2024**






**Inflation by Quadrant, February 2024 & March 2024**



**Distribution of Inflation for Food and Non-Food that Increased ≤10%, February 2024 & March 2024**





**Average Price of Unleaded Petrol RON95, Unleaded Petrol RON97 and Diesel, March 2023 - March 2024**





**Inflation by Main Group, February 2024 & March 2024**





**Inflation of Selected Countries, March 2023 - March 2024**



