In addition, the Pengana Funds will have a management fee of 1.35% per annum. All of these factors will influence the performance of the Pengana Funds. In line with the appointment, the funds are to be renamed, respectively:

- Pengana Axiom International Ethical Fund
- Pengana Axiom International Ethical Fund (Hedged)

Both funds will be invested in companies that are dynamically growing and changing for the better, more rapidly than generally expected; and where the positive changes are not yet reflected in expectations or valuation. The strategy concentrates its investments in global developed markets and may also invest in companies located in emerging markets.

Russel Pillemer, CEO of Pengana Capital Group said “we are excited to be able to bring such a high-quality investment product to our Australian investors. We pride ourselves on our track record of partnering with some of the world’s leading investment teams, and Axiom fits perfectly into this construct.”
