Description of Network Changes Planned:

BellSouth Telecommunications, LLC d/b/a AT&T Florida intends to retire copper facilities in distribution area (DA) 119002 in the Royal Palm wire center (WPCHFLRP) due to the impact of a road improvement project planned by Palm Beach County. This road construction will widen Royal Palm Beach Boulevard between Orange Boulevard and Tangerine Boulevard in West Palm Beach, Florida. County engineers have requested AT&T Florida to remove or relocate its facilities in the way of this road project before June 1, 2023.

AT&T Florida plans to migrate the customers served by the copper facilities to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and then retire the copper facilities.

Description of Reasonably Foreseeable Impact of the Planned Changes:

After implementation of this plan, copper facilities will no longer be available in DA 119002, so unbundled loops requiring copper facilities, e.g., digital subscriber line (DSL) or line-sharing circuits, will no longer be available in this DA. Currently, AT&T Florida records indicate a total of 36 assigned circuits, one of which is a competitive carrier circuit, affected by this network change. Notice has been sent to the affected carrier to make alternative arrangements.
