
1. Due to significant time expended in resolving complex pre-hearing motions, the Presiding Judge, on April 4, 2024, suspended the hearing schedule previously adopted in this proceeding

and directed the parties to propose a new schedule.¹ The FCC's Enforcement Bureau submitted a proposed schedule on April 15, 2024.² Antonio Cesar Guel indicated that he does not object to that proposed schedule.³ The Presiding Judge finds the Enforcement Bureau's proposed schedule to be reasonable and therefore adopts it, with slight modifications, as follows:

Deadline for Completion of Discovery	July 31, 2024
Deadline to Request Hearing on a Written Record ⁴	August 30, 2024
Deadline to File Motion for Summary Decision	September 30, 2024
Deadline for Response to Motion for Summary Decision	October 21, 2024
Deadline for Exchange of Exhibits, Witness Lists, And Written Direct Testimony	December 6, 2024
Deadline for Exchange of Witness Lists for Cross-Examination	December 13, 2024
Deadline for Objections to Exhibits and Written Testimony	December 20, 2024
Evidentiary Session (if needed)	January 13, 2025
Hearing Begins	January 14, 2025
Deadline for Proposed Findings of Fact and Conclusions of Law	To be determined after hearing
Deadline for Replies to Proposed Findings of Fact and Conclusions of Law	To be determined after hearing

2. Accordingly, **IT IS ORDERED** that the revised hearing schedule outlined above **IS ADOPTED**.
