On March 8, 2023, Tonaci Logistics, LLC, ("Applicant"), Lincoln, filed an application seeking authority as a contract carrier in Nebraska intrastate commerce in the transportation of passengers in Open Class service by van between points in Lancaster, Seward, Saunders, Douglas, Sarpy, Cass, Gage, York, Otoe, Saline, Butler, Johnson, Fillmore, Clay, Hamilton, and Hall Counties, and between said counties over irregular routes pursuant to a contract with the Nebraska Department of Health and Human Services, a Medicaid-managed care organization under contract with NDHHS, or another agent working on behalf of NDHHS. HHS Designation is yes. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on April 10, 2023.

On April 18, 2023, timely protests were filed by Camelot Transportation, Inc. and Triumph Transportation, Inc. On May 10, 2023, a timely protest was filed by Comstock Corporation d/b/a Action Cab. I granted the protests on May 19, 2023.

On May 19, 2023, Applicant filed a request to amend its application to restrict its operation to no more than two vehicles at any given time.


After review of the request and proposed amendment, I find that Applicant's request to amend its application in the above-captioned docket should be granted and Applicant's application be amended as provided herein.
