ORDER ASSESSING ANNUAL FEES

Pursuant to § 6.2-1532 of the Code of Virginia and 10 VAC 5-60-60 of the State
Corporation Commission's rules governing consumer finance companies, 10 VAC 5-60-5 *et seq.*,
IT IS ORDERED THAT licensees under Chapter 15 of Title 6.2 of the Code of Virginia be
