ORDER REISSUING CERTIFICATES

On September 28, 2023, EarthLink Business, LLC ("EarthLink" or "Applicant"), filed an application with the State Corporation Commission ("Commission") requesting that the certificates of public convenience and necessity ("CPCNs") previously issued by the Commission,¹ to provide local exchange and interexchange telecommunications services in the Commonwealth of Virginia, be cancelled and reissued to reflect a company name change ("Application"). The Company submitted proof of its name change to Windstream New Edge, LLC.

NOW THE COMMISSION, having considered the Application and applicable law, is of

the opinion and finds that the existing certificates in the name of EarthLink should be cancelled

and reissued in the name of Windstream New Edge, LLC.

Accordingly, IT IS ORDERED THAT:

(2) The certificate of public convenience and necessity to provide local exchange telecommunications services in the Commonwealth of Virginia, Certificate No. T-722, heretofore issued to EarthLink Business, LLC, is hereby cancelled and shall be reissued as Certificate No. T-722a in the name of Windstream New Edge, LLC.

(3) The certificate of public convenience and necessity to provide interexchange telecommunications services in the Commonwealth of Virginia, Certificate No. TT-271A, heretofore issued to EarthLink Business, LLC, is hereby cancelled and shall be reissued as Certificate No. TT-271B in the name of Windstream New Edge, LLC.

(3) Any tariffs on file with the Commission's Division of Public Utility Regulation or product guide available online in the name of EarthLink Business, LLC, shall be replaced reflecting the name change within forty-five (45) days of the date of entry of this Order.

(4) This case is dismissed.
