<b>No.</b>	<b>Clarification Sought</b>	<b>Response/Clarification by the Bank</b>
<b>1.</b>	A tenderer has requested clarification on the category of NCA Certification required.	The Bank clarifies that tenderers will be required to provide registration certificate by National Construction Authority as a Building/Civil Engineering Contractor Category NCA 6 and above.
<b>2.</b>	A tenderer enquired whether the existing gradient is to be maintained or there will be a new sloping other than filling up the small pockets where water can be seen stagnating once it rains.	Gradients to be maintained as they are.
<b>3.</b>	A tenderer enquired whether the tennis court sizes will be exactly as they are now or they will be increased or reduced in the case where you might require an Olympic size/standard tennis court or not.	Tennis courts sizes will be maintained as they are.
<b>4.</b>	A tenderer enquired whether the Bank makes advance payments toward the assignment	The Bank may extend an advance payment not exceeding 20% of the price of the tender and shall be paid upon submission of an advance payment bank guarantee issued by a reputable bank recognized by the Central Bank of Kenya (CBK) equivalent to the advance itself.
