3.	Page 17 item 3.1 while the project lead during the design stage is the Urban Designer. This is not the case during the construction/implementation stage. The project lead should be the Civil Engineer. Please confirm.	The Project Lead to be either of the following - Architect, Landscape Architect, or Civil Engineer With relevant registrations from AAK, BORAQS or EBK
4.	Page 17 -18 qualification and experience of key staff you have indicated the various consultants required for the proposal. Further to the TOR page 21, the scope of work 3.2a item 1, you have indicated that you will require a Construction Manager and a Project Manager. These experts have not been included in the evaluation process. Please confirm.	Yes, a Construction Manager is required as indicated in the TOR. A Project Manager will be appointed from the office of the Lead Consultant or relevant trade from the winning team.

**All other terms and conditions of the Tender Document remain the same.**
