[MOEF] Consumer Price Index, May 2023 (June 2)

The Consumer Price Index was 111.13(2020=100) in May 2023. The index increased 0.3 percent from the preceding month and rose 3.3 percent from the same month of the previous year. More

[MOEF] Monthly Industrial Statistics, April 2023 (May 31)

Statistics Korea released 'Monthly Industrial Statistics, April 2023' report on May 31, 2023. The Index of All industry production in April decreased by 1.4 percent from the previous month. More

[MOEF] The Tariffs on Eight Food Items Will Be Lowered to Ease Cost Burdens from Edible Products (May 30)

The government held the 22nd Cabinet meeting presided over by the Prime Minister on May 30 and decided to cut tariffs on seven items including agricultural, livestock, and fishery products from early June to ease the burden of living costs on households stemming from increased food prices. <u>More</u>

[BOK] Gross National Income, Q1 2023 (Preliminary) (June 2)

Real gross domestic product (real GDP, chained volume measure of GDP) increased by 0.3 percent in the first quarter of 2023 compared to the previous quarter, consistent with the figure given in the advance estimate. More

[BOK] National Accounts, 2022 (June 2)

Real gross domestic product (chained volume measure of GDP) increased by 2.6 percent in 2022. More

[BOK] Interest Rates, April 2023 (May 30)

In April 2023, the average interest rate on new deposits was 3.43%, down 13 basis points from the previous month. More
