

DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 50,000 MILLION TREASURY BONDS

Rs. 20,000 million Treasury Bonds under the series of 17.00% 2025'A' and Rs. 30,000 million Treasury Bonds under the series of 18.00% 2031'A' are to be issued through an auction on July 28, 2022.
