Therefore, tenderer / bidder shall quote their rates **inclusive of GST**, as applicable after study the same and **GST** will not be paid / reimbursed by CONCOR.
 12. If the overall rate, quoted by two or more qualified successful bidders, is the lowest and same, then the successful bidder will be selected on the basis of lottery in presence of concerned bidders. The Tender Evaluation Committee will conduct the lottery.

- (b) Bidders registered with **NSIC as electrical contractor** shall be exempted from the payment of Earnest Money Deposit (EMD) and tender cost on submission of valid registration as Electrical contractors.
- (c) MSEs units registered with agencies mentioned at Clause 3 of section-II shall be exempted from payment Earnest Money Deposit (EMD) and tender cost on submission of valid registration for Electrical contractors.
- (d) Registration certificate issued by any of the following agency for availing the exemption as electrical Contractor shall be submitted along with offer

In the event of Non Submission of valid Registration certificate from NSIC/ MSE by Bidders seeking exemption the bid shall be summarily rejected and financial bids shall not be opened.
