I submit my report as under:

- As informed by the Company, Postal Ballot Notice along with explanatory statement and remote e-Voting instructions were sent to all those Members, whose e-mail address were registered with the Company or Registrar and Share Transfer Agent i.e. Alankit Assignments Limited, or with their respective Depository Participants and whose names appeared in the Register of Members of the Company/ List of Beneficial Owners as maintained by the Depository Participants as on April 8, 2022 ('cut-off date').
- The management of the Company is responsible to ensure the compliance with the requirements of the Act and the Rules thereof including Circulars/ SEBI Regulations in respect of the resolution contained in the Postal Ballot Notice including the dispatch of the notice to the Shareholders.
- My responsibilities as Scrutinizer is restricted to make a Scrutinizer's Report of the votes cast in 'Favour' or 'Against' the resolution contained in the Postal Ballot Notice, based on the reports generated from the e-voting system provided by National Securities Depository Limited (NSDL).
- 4. The Company has published an advertisement on April 17, 2022 regarding service of Postal Ballot Notice to eligible members in English language newspaper "Financial Express" and in Hindi language newspaper "Hindustan ".
- 5. The Members of the Company holding shares as on cut-off date were entitled to vote on the resolution as contained in the Postal Ballot Notice and could vote through remote e-voting facility only as per the MCA Circulars. Members were provided with the facility to cast their votes on the designated platform of NSDL.
- The remote e-Voting commenced on April 17, 2022, 09:00 A.M. and ended on May 16, 2022, 05:00 P.M. Further, the remote e- voting process was monitored through the Scrutinizer's secured link provided by NSDL on its designated website i.e. 'https://www.evoting.nsdl.com/'.



7. The remote e-voting was unblocked on May 16, 2022 after 05:00 P.M. in the presence of two witnesses i.e. Ms. Priyanka and Ms. Jayshree who are not in the employment of the Company and have signed below:

- 8. The particulars of remote e-voting report generated from electronic registry of NSDL have been entered in a separate Register maintained for this purpose.
- E-votes cast upto 05:00 P.M. on May 16, 2022 are considered for the purpose of this report. The remote e-voting was reconciled with the register of members of the Company as on cut- off date as maintained by RTA of the Company.
- 10. As on cut- off date, the fully paid-up share capital of the Company was Rs. 15,92,81,139/-(Rupees Fifteen Crore Ninety Two Lakh Eighty One Thousand One Hundred Thirty Nine Only) divided only 15,92,81,139 (Fifteen Crore Ninety Two Lakh Eighty One Thousand One Hundred Thirty Nine Only) equity shares of Rs. 1/- (Rupees One Only) each.
