Both the covers containing **"COMMERICAL BID" and "PRICE BID"** are to be put in one sealed cover super scribing the TENDER NO and DUE DATE and addressed to **DEPUTY GENERAL MANAGER (TOS & DISPOSALS), TAMILNADU NEWSPRINT AND PAPERS LIMITED, KAGITHAPURAM POST, KARUR DIST - 639 136, TAMILNADU.**

The due date for submission of **"COMMERCIAL BID"** (Commercial Bid, EMD and Tender fee details along with DD) and **"PRICE BID"** is 02.06.2022 at 3.00 PM.

The **Commercial Bid** will be scrutinized first and those who qualify in the **Commercial Bid** satisfying all the tender conditions will only be considered for Price Bid stage.

QUALIFYING FACTORS OF THE TENDER:

1. Submission of Price Bid with seal and signature. The rate quoted to be written in figure and words without correction.

PRICE BID STAGE:

- SCOPE OF WORK:** Sale is on "AS IS WHERE BASIS" and "NO COMPLAINT BASIS". 15. **The rate offered by the highest Bidder will remain firm throughout the period of Sale Order/ Contract.**
16. While taking delivery of the Waste and Scrap material, if any damage is caused to the premises or other machinery lying nearby, the Company shall recover all such costs required to reinstate the damage into the original position and stop delivery of the material till all the costs are paid.
17. Material lifting shall be as per the guidelines of TNPL only. Buyer shall have no right to choose / pick the Waste and Scrap material out of due total lot.
18. **INSURANCE FOR WORKMEN EMPLOYED BY THE BUYER:** The buyer should submit Insurance Policy under workmen compensation Act / road safety for the staff / workmen engaged for co-ordination / material lifting by them for the entire contract period before commencement of work. TNPL is not responsible for any accidents occurred to employees of buyer/ any other person engaged by the buyer.
19. **DRIVING LICENCE:** The drivers employed by the buyer shall possess valid driving license and TNPL reserves the right to check these papers and certificate of Insurance as and when required. TNPL is no way be responsible for violation of transport regulations by the buyer and their crew.
20. The Buyer shall be responsible to ensure that their employees follow safety regulations and as per TNPL stipulations and other statutory regulations. 22. 23. In case of any dispute regarding the contract, the decision of the Company shall be final and binding. If there is any dispute as to the last or highest bid, the dispute shall be determined by the company and their decision shall be final and binding to all.
24. Buyer and his men are subject to the security rule of TNPL in force while in the TNPL premises. Buyer's workmen, agents or representatives shall not commit any nuisance, theft or indulge in any anti-social activities in the premises and the Buyer shall be liable for the good conduct, safety and discipline of his workmen. 28. Commencement of work: The buyer shall commence the work immediately on receipt of intimation /award of sale order.
